MINUTES OF BUDGET AND CONTROL BOARD MEETING

MARCH 1, 1978 3:00 P. M.

The Budget and Control Board met at 3:00 p. m. on March 1, 1978 in the Governor's Conference Room with the following members in attendance:

Also attending were Board Secretary State Auditor W. T. Putnam, Governor's Executive Assistant Walter R. Pettiss and his Assistant A. E. Reiser, Planning Officer Jesse Coles and Assistant State Auditor William A. McInnis.

The following items of business were considered:

MINUTES OF PREVIOUS MEETING - Budget and Control Board members previously had been furnished with a draft version of the minutes of the meeting held on February 15, 1978.

Upon a motion by Mr. Patterson, seconded by Representative Mangum, the Budget and Control Board approved these minutes as written.

EXECUTIVE SESSION - State Auditor Putnam announced that one contractual matter and two personnel items had been proposed for consideration in Executive Session. The Budget and Control Board agreed without objection to consider these matters whereupon Governor Edwards declared the meeting to be in Executive Session.

RATIFICATION OF EXECUTIVE SESSION ACTION - Following the Board's consideration of the Executive Session items, the meeting was opened and the following actions taken by the Board in Executive Session were ratified without objection:

(1) Authorized the Aeronautics Commission to accept the bid of Stevens Aviation for the replacement of a Baron B-55 airplane and authorized the sale to the highest bidder of a Cessna 310 airplane;

(2) Received as information the findings and recommendations of the State Employee Grievance Committee in a case involving the Department of Consumer Affairs; and

(3) Rejected the findings and recommendations of the State Employee Grievance Committee in a case involving the Second Injury Fund.

Following this action, the Budget and Control Board returned to its regular session agenda for consideration of the following matters.

POLL AGENDA - The three items included on the Poll Agenda for the present meeting were approved by the Budget and Control Board. These Poll Items are specifically identified as such in these minutes.

DIVISION OF GENERAL SERVICES - POSITIONS ABOVE AUTHORIZED NUMBER
(POLL ITEM 1) - The Division of General Services requested Board approval of the following two positions (which have been approved by State Personnel and which are to be financed from revenues): (1) Chief of Maintenance, Grade 25, to head maintenance personnel at the State Park Health Center in anticipation of the assumption by General Services of maintenance responsibilities in July, 1978; and (2) one Offset Press Operator II, Grade 14, to print briefs for the Supreme Court. These positions are in excess of the number authorized.

Following a brief discussion, the Budget and Control Board authorized the establishment of the two referenced positions, as required by Section 147 of the 1977-78 Appropriation Act.

Information relating to this matter has been retained in these files and is identified as Exhibit I.

DIVISION OF GENERAL SERVICES - PRINTING EQUIPMENT REQUESTS (POLL ITEM 2) - The State Printing Officer and the Division of General Services recommended Budget and Control Board approval of the following printing equipment purchases:

A. Department of Health and Environmental Control: one A B Dick Offset Duplicator at a cost, less trade-in of A B Dick Duplicator, Mimeograph and related printing equipment, of \$2,500 with no additional personnel required; and

B. University of South Carolina: one reconditioned A B Dick Offset Press at a cost of about \$7,500 to replace a 1965 model with no additional personnel required.

Following a brief discussion in which Governor Edwards requested State Auditor Putnam to review with General Services Division Director McEachern the procedures for assessing printing equipment needs, the Budget and Control Board without objection approved the referenced requests as recommended by the Division of General Services.

Information relating to this matter has been retained in these files and is identified as Exhibit II.

DIVISION OF MOTOR VEHICLE MANAGEMENT - MOTOR VEHICLE PURCHASE REQUESTS (POLL ITEM 3) - Motor Vehicle Management Division Director Allan Spence recommended Board approval of the following motor vehicle purchases:

- (1) Department of Education: two Ford LTD II (Class III) vehicles as replacements for assignment to Deputy Superintendents;
- (2) Department of Youth Services: one 15-passenger maxi-van as a fleet addition; and (3) Department of Corrections: one 15-passenger van as a fleet addition.

Following a brief discussion, the Budget and Control Board without objection approved the referenced requests, as recommended by Division Director Spence.

Information relating to this matter has been retained in these files and is identified as Exhibit III.

JOHN DE LA HOWE SCHOOL - ON-CAMPUS HOUSE FOR EMPLOYEE - State Auditor Putnam reported that Superintendent L. S. Brice has requested authorization to construct a replacement house for occupancy by the School's business manager. The estimated cost of the 3-bedroom, 1,682 square foot house is \$50,000 and Superintendent Brice proposes that it be financed by funds from the Duke Endowment. Mr. Putnam noted that the School presently has 14 housing units including 12 single-family dwellings for which a monthly rental of \$25.00 each is now charged to the employee occupants. The unit to be replaced is considered beyond repair as a result of termite infestation.

Mr. Putnam emphasized that this request involves a question of the need for the housing and a question relating to the current practice of charging less than a fair market rental for housing owned by the School. Mr. Putnam expressed the view that the agency made a very good case on the need to provide housing in order to attract staff but he expressed concern

that the rental question, now in the hands of a committee of the General Assembly, has not yet been resolved. He pointed out that the State Personnel Division has taken the position that agency-provided housing is not taken into account in determining salary levels assigned to any employee and that such perquisites are illegal.

Mr. Putnam recommended that the John de la Howe School be allowed to demolish the house formerly occupied by its business manager and to replace that unit provided that the employee who occupies the replacement unit will do so as a condition of employment with the School and that that condition would continue to be effective in the event the rental charge is adjusted at some future time.

Following a brief discussion, upon a motion by Senator Dennis, seconded by Mr. Morris, the Budget and Control Board authorized the John de la Howe School to demolish a house formerly occupied by its business manager and build a replacement unit using funds from the Duke Endowment. The motion adopted by the Board stipulated that the employee who occupies the replacement unit will do so as a condition of employment with the John de la Howe School and that that condition would continue to be effective in the event rental charges are adjusted at some future time.

Information relating to this matter has been retained in these files and is identified as Exhibit IV.

APPEARANCE OF MR. ROBERT RUSSELL - DEPARTMENT OF CORRECTIONS

CONSTRUCTION PROGRAM - At the request of Senator Dennis, the Budget and Control Board without objection agreed to add to the agenda of the present meeting an appearance by Mr. Robert Russell, of Ruscon Construction Company, and Mr. R. Gene Ellis, manager of the Building Division of the Carolinas

Branch, Associated General Contractors of America, Incorporated, for the purpose of reviewing the Board's approval of the construction program involving inmates to be undertaken by the Department of Corrections.

Mr. Russell indicated that the Department of Corrections construction program had been examined very carefully by contractors and other groups. He also indicated that these interests understand the need to provide additional correctional facilities and to put inmates to productive work and that the contractors have taken the position that they want to give guidance to the endeavor in order to help insure that the products of it are usable. Mr. Russell questioned the necessity of establishing what he termed as a State-financed construction company when so many skilled persons and private firms are available. He also expressed doubt that the Department of Corrections could acquire the qualified staff necessary to handle the assignment effectively and efficiently. Mr. Russell also questioned the feasibility of using inmate labor because of transportation, security, selection and incentive problems.

Mr. Russell suggested that the Budget and Control Board could not know what the ultimate cost of the inmate-constructed projects will be and that the State may be violating the law by stepping over into an area which has been customarily handled by private enterprise. He suggested the possibility of a blending of licensed contractors and inmate labor as an approach but cautioned against the use of unqualified persons because of the likelihood of inferior end results.

Mr. Russell urged that legitimate cost controls be established and strongly suggested that a coordinated effort be undertaken involving licensed contractors in the interest of insuring that the projects are accomplished within the dollars available.

Governor Edwards expressed appreciation to Mr. Russell for his advice and reviewed the circumstances involved in the Board's decision on the Department of Corrections construction program. Governor Edwards pointed out that federal courts are pressuring the State to do something about the crowded conditions in correctional facilities and that limited resources require that the State examine all alternatives in order to meet the requirements. Governor Edwards indicated that this search for alternatives had involved numerous groups, including representatives of the Associated General Contractors, and had resulted in the use of prototypical designs for the correctional facilities to be constructed. Governor Edwards also pointed out that the Department of Corrections previously constructed certain facilities using inmate labor as is proposed in the current program.

Governor Edwards concluded by acknowledging that there are risks involved in the approach being taken and by welcoming any help the contractors might offer. He reiterated a willingness to meet with any interested party to go through the whole presentation on the Department of Corrections construction program approved by the Board.

Following this discussion, Mr. Russell and any other interested group were invited to attend a presentation on the Department of Corrections construction program already scheduled for March 3, 1978 at 1:30 in the Governor's Conference Room.

THE CITADEL - \$500,000 PLANT IMPROVEMENT BOND ISSUE - Upon a motion by Mr. Patterson, seconded by Mr. Morris, the Budget and Control Board adopted a Resolution approving the sale of a \$500,000 Plant Improvement Bond, the proceeds of which are to be used to finance the renovation, improvement and refurnishing of Cadet Barracks Law and Stevens, and authorizing the sale of the referenced Bond at a privately-negotiated sale.

The original of the referenced Resolution has been retained in these files and is identified as Exhibit VI.

FINANCE DIVISION, GRANTS & CONTRACTS REVIEW UNIT - GRANT AND CONTRACT REQUESTS - State Auditor Putnam, accompanied by Grants Services Administrator George Oliver, presented a list of 76 grant and contract requests involving a total of \$14,023,994 for consideration by the Board. This total includes 19 subcontracts between state agencies involving \$1,520,724 of federal funds.

Mr. Putnam called attention to request Number 5 (Control Number 8-H12-036) and pointed out that this program is Clemson University's whole Public Service Activities program and that \$6,300,000 of State funds should be shown bringing the program total to \$11,549,248. Mr. Oliver noted that request number 76 (Control 8-PO8-013) relating to a Land Resources Commission request had been withdrawn at the request of the agency.

Following a brief discussion, upon a motion by Mr. Morris, seconded by Representative Mangum, the Budget and Control Board approved the 75 requests on the list presented by the Grants and Contracts Review Unit, subject to the conditions recommended.

A summary of Budget and Control action on federal grant and contract requests to date was distributed and Governor Edwards noted that 2,280 full-time employees, including 73 in the requests considered at the present meeting, have been approved since July, 1977.

FINANCE DIVISION, GRANTS & CONTRACTS REVIEW UNIT - ARTS COMMISSION
REQUESTS FROM 2/15/78 MEETING - State Auditor Putnam noted that three requests by the Arts Commission were not acted on at the 2/15/78 meeting to permit a study of the possibility of including funds in these requests to cover rental costs. Mr. Putnam advised the Board that these three proposals could not be modified to include funds for rents and recommended their approval by the Board.

Following a brief discussion, the Budget and Control Board without objection approved request numbers 110, 111 and 112 carried over from the 2/15/78 meeting.

Information relating to this matter has been retained in these files and is identified as Exhibit VIII.

MOTOR VEHICLE MANAGEMENT DIVISION - VEHICLE ASSIGNMENT CRITERIA
AMENDMENT AND PURCHASE REQUEST - Motor Vehicle Management Director Allan J. Spence appeared before the Budget and Control Board to recommend that the Commissioner of Labor be added to the list of full-time commissioners eligible for assignment of a Class II vehicle. Mr. Spence also recommended that, if this proposed amendment is approved, approval of the purchase of a Ford LTD with a split front seat as a replacement vehicle for the Commissioner of Labor be granted.

Following a brief discussion, upon motion by Mr. Morris, seconded by Mr. Patterson, the Budget and Control Board approved the vehicle assignment criteria amendment as recommended by Director Spence and also approved the purchase of a Ford LTD as a replacement vehicle for the Commissioner of Labor.

Information relating to this matter has been retained in these files and is identified as Exhibit IX.

FUTURE MEETINGS - The Budget and Control Board agreed to hold a special meeting to consider its supplemental appropriation and capital improvement bond authorization recommendations on Wednesday, March 8, 1978 at 3:30 p. m. The Board also agreed to hold its next regular meeting at 3:30 p. m. on Wednesday, March 15, 1978.

EXECUTIVE SESSION - State Auditor Putnam announced that three personnel matters and one contractual item had been proposed for consideration in Executive Session. The Budget and Control Board without objection agreed to consider these matters whereupon Governor Edwards declared the meeting to be in Executive Session.

RATIFICATION OF EXECUTIVE SESSION ACTIONS - Following the Board's consideration of Executive Session items, the meeting was opened and the following actions taken by the Board in Executive Session were ratified without objection:

- (1) Approved the salary of the new Commissioner for the Blind;
- (2) Approved an 8 percent salary increase for the newly-appointed Deputy Commissioner for the Blind;
- (3) Authorized the State Personnel Division to continue on an as needed basis the consultant services of Tillinghast and Company in

(4) Was advised that the Medical University request to establish a new position had been withdrawn because of its relationship to a pending study of higher education salaries.

The meeting was adjourned at 5:40 p.m.

I. Personnel

Statute 44-31-510 passed in 1972 transferred title to all real property at State Park Health Center to the State of South Carolina to be administered by the State Budget and Control Board. The Division of General Services has worked with the Department of Health and Environmental Control for the past five years allowing DHEC to provide the maintenance and operation of the real property at this facility. We anticipate completion of the DHEC Lab in July of 1978 and we propose to assume the maintenance and operation of the State Park real property at the same time we provide the maintenance and operation of the Lab building. We will transfer as many of the maintenance and operation personnel as can be mutually agreed upon between our agencies but we request permission to employ a Chief of Maintenance at a grade 25 with a salary range of \$12,515-17,422 to head the maintenance personnel at State Park Health Center. This position has been approved by State Personnel and funds will be provided from other sources (revenue).

Personnel

On December 7, 1977, the Board approved equipment to be used in printing briefs for the Supreme Court and in that approval we recognized that additional personnel would be required to handle this function. State Personnel has approved the position of Offset Press Operator II, grade 14, with a salary range of \$7018-9608. It is requested that we be allowed to employ the person to fill this position. The estimated savings to print the Supreme Court briefs in the Brown Building Print Shop was \$330,000 annually. The savings projected at that time included equipment and personnel. Monies for the salary will come from revenue sources.

Mr. Allan J. Spence, Director of Motor Vehicle Management (DMVM), requests permission to appear before the State Budget and Control Board (SB&CB) regarding the below listed vehicle requests:

- A. The S.C. Department of Education (SCDE), requests permission to purchase two (2) Ford LTD II (Class III) as replacement vehicles for assignment to Deputy Superintendents.

Recommendation: Approval. This is consistent with previous approvals and provided for in the Motor Vehicle Management Manual. Please see enclosure (1).

- B. The Department of Youth Services (DYS), requests permission to purchase one (1) 15 passenger maxi-van as a fleet addition. This unit will be used to transport students from the R & E Center to family courts all over the State. Agency certifies that they have no other vehicle available for re-assignment. Please see enclosure (2).

Recommendation: Approval.

- ~~C. The S.C. Department of Labor (SCDL) requests permission to purchase one (1) Ford LTD (Class II) as a replacement vehicle for the Commissioner. Additionally, SCDL requests permission to purchase a split front seat to give the Commissioner additional leg room when he is riding as a passenger. Normally, an agency with this total budget would rate the Plymouth Volare (Class IV). However, in this particular case, it would appear that the Commissioner, SCDL should be considered a "Commissioner" in the same manner as an ABC "Commissioner" since he too is appointed by the Governor and confirmed by the Legislature. Please see enclosure (3).~~

~~Recommendation: That the Commissioner, SCDL, be added to the list of full-time Commissioners, as specified in footnote #2 of the vehicle assignment criteria, thus making him eligible for a Ford LTD (Class II) vehicle. It is also recommended that the split front seat be approved for purchase.~~

- D. The S.C. Department of Corrections (SCDC), requests permission to purchase one (1) 15 passenger van as a fleet addition to transport inmates from all counties in the Appalachian Region to Intake Service in Greenville. Commissioner, SCDC, states there is no vehicle available to fill this need. Please see enclosure (4).



Mr. John A. McPherson, State Engineer, requested that we write you and explain further the need for a staff home requested on Form E-1, submitted to Mr. McPherson's office on January 20. We included the basic information on the Form E-1, which was approved by our Board of Trustees on January 11, 1978. You will note that our Duke Endowment funds are to be used.

As you no doubt know from the history of child care homes and institutions, some staff housing has been provided, as it was felt necessary. When the present campus plan was developed here in 1938, the Superintendent's home was given a prominent location near the administration building, chapel, and cottages. The home for the dairyman was located very near the dairy. The farm managers' homes were located away from cottages and in keeping with their positions. One home was on Little River, where our dam and generating plant were located.

In "Standards of the National Association of Homes for Children for Not-for-Profit Institutions and Group Homes Providing Residential Group Care of Children", copyright 1977 by the N.A.H.C., your attention is directed to two appropriate statements. First, on page 17, Section I. D. 1., we find "Dining facilities and equipment shall be provided for all children and staff residing on the premises." *** And, on page 19, Section I. G. 1., "Staff sleeping quarters shall be separate from those used by the children", and 2., "Staff dining and recreational areas may be part of the general child caring facilities, depending on the nature and needs of the children and staff." As you are fully aware, most of the child care facilities in South Carolina provide for selected staff to live on campus.

The philosophy of the John de la Howe School program has meant that staff would be on campus and a part of the total community atmosphere where children are reared. Family living, character development, cultural uplifting, and after-hour association with children have contributed to the growth and development of the children we serve. The thought of putting children by themselves here in a rural area with one house-parent on duty, would give many the feeling of being put in a pasture, as you would cattle, when someone would return the next day to see about them.

The de la Howe community provides a volunteer fire department. The campus staff have been successful in preventing the need for extra staff for night duty and security guards around the clock. The campus is open 365 days each year, with some children present, as well as the dairy herd. The property and lives of children demand that some campus personnel be present—whether for storm and tornado watches,



alerts, warnings, etc. or for help when ice, snow, or storms destroy power lines (owned and serviced by the school) or just when a furnace goes out, as one did at 3:30 A.M. several days ago. I have been called on several times recently to take children to the hospital in the middle of the night.

The home requested is for the business manager, who receives shipments—some trucks "are running behind" and arrive after nightfall. He is concerned with the care and maintenance of buildings and property. He helps in transporting children after hours, as they compete in basketball, track, play practices, annual and newspaper staff meetings, etc. at McCormick. This prevents one person being tied up for day and night duty seven days each week. Our children are allowed to participate in the development and growth activities of the average home child.

Our program and services to children demand the best staff we can locate. There are no houses between here and Abbeville or McCormick available. There might be one or two between Willington and Calhoun Falls. Our Board of Trustees realizes we do not have the best in housing. In fact, some we have are sub-standard; but the Board wishes to replace a demolished sub-standard home in order to retain an outstanding employee, since to get a new employee we would be asked for housing or refuse the job, as we find occurs so often. Our program is built on the premise that selected staff will be on campus.

RE: Department of Corrections' Capital Improvement Plan

Gentlemen:

The decision to approve Phase I of the Department of Corrections' Capital Improvement Plan which allows the Department to establish a construction staff and undertake construction projects, apparently was based on the concept that savings in construction costs could be realized by developing an in-house construction staff and by using inmate labor.

We have seen figures that indicate a savings in excess of 30% would be realized on the projects the Department plans to construct themselves. At best, these are speculative savings and we would like to suggest that you give consideration to having the Legislative Audit Council audit some of the projects that have been constructed by the Department to verify that these anticipated savings are realistic. An experienced contractor can often under-estimate the cost of a project, consequently, this makes our industry extremely leery of cost saving statements. The proposed savings for projects that the Department plans to construct themselves could be analogous to having your car repaired. The final all-inclusive cost may have little similarity with the original estimate.

We feel the proposal approved by the Budget and Control Board, which allows the Department of Corrections to develop their own construction capabilities, has many aspects that cannot be evaluated strictly on a monetary basis.

We feel the matter of warranties and guarantees is a very important item that you may not have fully considered. In constructing a public building, a contractor is required to guarantee the workmanship and equipment incorporated into the building in accordance with the contract provisions. The State will not have this protection on buildings built by the Department of Corrections and the public could

face paying for unanticipated costs of repairs after the structure is completed. Under a construction contract, most of these items are found and corrected during the guarantee period.

What type of controls will the public be assured of when the Department buys materials for one of its projects? A contractor, by contractual agreement, has to furnish all the labor, materials and equipment necessary to complete the project. If one of his employees ruins a piece of equipment, he has to replace it at no cost to the owner. If the Department of Corrections ruins a piece of equipment, the public is going to have to pay for the replacement cost with very little chance of the average South Carolinian knowing anything about it.

How will the purchasing of building materials and supplies be handled? We assume the Division of General Services will do the purchasing for the Department of Corrections. We believe this is proper in that some degree of accountability for the expenditure of public funds can be maintained, however, does this procedure lend itself to quantity purchasing, cash discounts and etc.? Depending on how it is ordered, the price of a door can vary by as much as 50%.

Under the proposed program, the actual cost will not be available for public scrutiny until the project is completed. We believe public officials have a basic obligation and responsibility to the taxpayers to know the cost of a project before it is started and to provide proper and complete accountability for public expenditures. We are confident and experience has demonstrated that the maximum efficiency and cost accountability are obtained through the lump sum single contract competitive bid process.

It has been demonstrated that an experienced construction firm can carry out construction requirements more rapidly, efficiently and economically than can full-time day labor forces who do not have the organization or broad experience gained through competition. The day labor manager does not have the competitive incentive to constantly search for ingenious methods to increase efficiency and save money. All one has to do to verify this point is observe a city maintenance crew repairing a hole in the street.

The cost of this program has to be borne by the taxpaying citizen of South Carolina and to remove a segment of this construction from the free enterprise system certainly has to reflect on revenues returned to the State in the form of taxes, reduced unemployment, etc. and certainly should be a consideration in evaluating the Department's Capital Improvement Plan.

The failure to seek competitive bids for various segments of the program would, in our opinion, appear to violate the spirit of Section 10-1-80 which requires advertising for competitive bids on State projects exceeding \$30,000. We seriously question whether the South Carolina Legislature intended for Section 10-1-90, which excludes the Correctional institutions from Section 10-1-80, to be applied to projects of the dollar magnitude proposed by the Department of Corrections.

In conclusion, we feel it is not in the best interest of the citizens of South Carolina for the Corrections Department to purchase construction equipment and hire a construction staff for the purpose of constructing their own facilities. We would recommend that the Department's efforts be directed toward developing a procedure whereby inmate labor could be used in conjunction with the contractor's labor force. This would still allow the competitive bid process to be utilized in awarding single lump sum contracts for projects governed by Section 10-1-80. This procedure protects the public in that they know the cost of the project before it is built, would provide rehabilitation for the inmates, eliminates the need for the State to develop an increased staff to administer the program, the purchasing of equipment and would still allow any savings attributable to using inmate labor to be realized by the State.

We appreciate the opportunity to express our continued concern regarding this program and trust that we may work together in developing a program that will be in the best interest of the citizens of South Carolina.

A RESOLUTION

APPROVING THE UNDERTAKING OF THE BOARD OF VISITORS OF THE CITADEL, THE MILITARY COLLEGE OF SOUTH CAROLINA TO ISSUE A \$500,000 PLANT IMPROVEMENT BOND, SERIES 1978, PURSUANT TO ACT NO. 762 OF 1976, AS AMENDED, APPROVING THE SALE OF THE \$500,000 PLANT IMPROVEMENT BOND, SERIES 1978 AT A PRIVATELY NEGOTIATED SALE PURSUANT TO THE AUTHORIZATION OF ACT NO. 762, AND APPROVING THE FACILITIES TO BE FINANCED THEREBY.

BE IT RESOLVED BY THE STATE BUDGET AND CONTROL BOARD IN THE STATE OF SOUTH CAROLINA IN MEETING DULY ASSEMBLED:

ARTICLE I

FINDINGS OF FACT

Section 1.01

On September 17, 1976, the Board of Visitors of The Citadel, The Military College of South Carolina (hereinafter referred to as "The Citadel"), adopted the Plant Improvement Bond Resolution as a means of providing for the issuance of bonds pursuant to Act No. 762 enacted at the 1976 Session of the General Assembly of South Carolina (hereinafter referred to as Act No. 762). Pursuant to express provision of the Plant Improvement Bond Resolution, the Board of Visitors (hereinafter referred to as the "Board"), on February 3, 1978 adopted a resolution expressed to be supplementary to the Plant Improvement Bond Resolution (hereinafter referred to as the "Supplemental Resolution"), in order to make provision for the issuance of a Five Hundred Thousand Dollars (\$500,000) Plant Improvement Bond, Series 1978 (hereinafter referred to as the Plant Improvement Bond, Series 1978).

Section 1.02

There has existed a great need to renovate, improve and refurnish those certain Cadet Barracks at The Citadel known as Law and Stevens and on January 25, 1977, the State Budget and Control Board of South Carolina (hereinafter referred to as the "State Board") did approve and authorize the construction of such renovation, improvement and refurnishing to those Cadet Barracks. At that time arrangements were made with the State Treasurer to advance a portion of the moneys required therefor and, at the present time, the improvements to those Cadet Barracks are substantially complete. In order to pay back the temporary borrowings and to complete those improvements, it has been found by the Board that Five Hundred Thousand Dollars (\$500,000) is now required.

Section 1.03

Pursuant to the authorization of Section 27 of Act No. 762, the Board provided in Section 5.01 of the Supplemental Resolution for the Plant Improvement Bond, Series 1978 to be sold at a privately negotiated sale. Provision was made to request the State Treasurer of South Carolina to invite bids from the major banking institutions within South Carolina and for the Plant Improvement Bond, Series 1978 to be issued in the form of a single, fully registered bond and awarded to the bank offering to purchase the Plant Improvement Bond, Series 1978 at the lowest interest cost to The Citadel in accordance with the requirements of the Supplemental Resolution.

Section 1.04

By express provision of Act No. 762, the approval of the State Board, by resolution duly adopted, must be obtained prior to the issuance of bonds issued pursuant to Act No. 762; further, Act No. 762 requires the obtaining of the approval of the State Board if bonds issued pursuant thereto are sold at a privately negotiated sale.

Section 1.05

On the basis of the foregoing facts, it is proper to take the necessary actions herein described and to give the approvals set forth in Article II.

ARTICLE II

AUTHORIZATIONS AND APPROVALS

Section 2.01

Approval and authorization are hereby given to the sale of a \$500,000 Plant Improvement Bond, Series 1978 of The Citadel and the use of the proceeds therefrom to:

- (a) pay to the State Treasurer of South Carolina the principal amount of moneys borrowed therefrom, with accrued interest thereon which moneys have been used to defray a portion of the cost of the renovation, improvement and refurnishing of the Cadet Barracks known as Law and Stevens; and
- (b) pay the remaining cost of the renovation, improvement and refurnishing the Cadet Barracks known as Law and Stevens.

Section 2.02

Approval and authorization are hereby given to the sale of the Plant Improvement Bond, Series 1978 at a privately

negotiated sale in accordance with the requirements and provisions of the Supplemental Resolution heretofore adopted by the Board.

Section 2.03

All action heretofore taken by the Board and Officers of The Citadel as set forth hereinabove is hereby approved, ratified and confirmed in all respects.





February 15, 1978, by the Budget and Control Board

Background:

Requests for approval of three South Carolina Arts Commission programs from the National Endowment for the Arts (NEA) were deferred by the Budget and Control Board at the February 15, 1978, meeting until an investigation into space requirements for the Arts Commission could be conducted.

The investigation was conducted during the week of February 21 with the Arts Commission, Governor's Office of Manpower, and the General Services Division.

Facts obtained indicated that the Arts Commission had obtained federal grants which increased their personnel staff without sufficient federal funds to provide additional space necessary to house these personnel. This increase has created a need for additional space.

Discussion:

The Arts Commission had obtained over one million dollars from the National Endowment for the Arts and the State Manpower Office through the CETA program. These funds allowed less than 2.7% for administrative purposes and are insufficient to rent additional required space.

The type of programs engaged in by the Arts Commission are generally 50/50 matching programs with the exception of the CETA Title II and VI funds, which are 100% federal and which do not allow sufficient administrative costs to cover rental of additional space. Further, these NEA funds, which constitute the bulk of their federal programs, are generally "flow-through" funds and do not allow sufficient funds for administrative support for space rental.

Additionally, the General Services Division has requested supplemental appropriations for the Commission in the amount of \$39,000 through June, 1978, in order to rent a new location for the Commission and to move all three elements of the Commission into one location. General Services also plans to renovate the Commission's current location, The Boylston House, which will create additional space problems.

The three programs that were deferred, State-Federal Partnership Program (8-H91-027), Federal/State Development Program (8-H91-025), and Stage South (8-H91-023), are the basic matching grants that constitute the

main effort of the Commission. These programs are all currently on-going programs and do not increase the space problem to any greater degree than is already being experienced.

However, the CETA grants, which cannot support the additional space, are new programs in 1977-78 and have generally created the bulk of the overcrowded conditions at Boylston House and the Devine Street location of the Arts Commission.

Conclusion:

The Arts Commission has a space problem that cannot be resolved by requesting additional federal funds from their various on-going federal programs.

There is an indication their request for supplemental appropriations will be denied for 1977-78.

Further, the Arts Commission did not plan adequately when they built up their staff without sufficient funds available to meet the increased space requirements.

Additionally, the Arts Commission must reduce their federal programs in the areas which will not affect their basic mission but in areas that will reduce their staff and therefore reduce the space problem.

Finally, the Arts Commission's basic State/Federal Partnership, Development Program, and Stage South, which constitute the main thrust of the Commission, should be allowed to continue as without these funds the Arts Commission would cease to exist.

Recommendations:

1. The Budget and Control Board approve the three deferred grant requests as these grants are the primary programs that provide federal support to the state.

2. No new programs be approved for the Commission by the Budget and Control Board unless the necessary funds are made available for space necessary to support these programs.
