They felt that the Board, especially the Chair, failed to give their testimony adequate consideration in strictly adhering to short time limits. They were extremely upset, so Director Adger was asked to directly respond to their concerns. They met with him at his office and detailed each of their concerns. Yesterday, he received this response:

Dear Governor Haley:

I would like you to consider declaring South Carolina in a state of emergency regarding homelessness. Los Angeles is appropriating \$100 million toward combatting the plight of those without permanent residency. I am encouraging you to take preventative steps through funding and self-help programs to combat homelessness in our state.

Please call for an emergency meeting to discuss this matter with all of the interested parties. Homelessness is clear and present in all the counties throughout the state of South Carolina. We work to get emergency food and shelter, but there is not enough reasonably priced housing to get the homeless off the streets. There is a dire need for additional affordable housing.

Thank you for your consideration of declaring South Carolina a state of emergency for homelessness.
