Matthew - I hope this finds you well. We have a couple of housekeeping items to take care of to finalize things:

1- There are a few items that the parties agreed to in the 3/24 version of the Settlement Agreement that were not included in your 6/1 draft. by separate email, Holly will send you your 6/1 draft with these additions.

2- We spoke about Plaintiffs desire to keep the parties agreed upon payment schedule for attorney's fees out of the Settlement Agreement. Obviously, it's important for Defendants to memorialize the agreed upon schedule. It's my assumption that Judge Duffy will include the payment schedule in the arbitration order. we may have already discussed this and I just don't recall, but please confirm.

3- After we get a copy of the Settlement Agreement that incorporates the negotiated additions discussed above and we have an understanding about memorializing the payment schedule, we will move forward with signatures and can get them over to you asap. With

the last day of session, the Governor and her staff are obviously busy, but we will make this a priority.

4- We'll look for your press statements later this afternoon, and we will share our proposed media release with you as soon as we can. I'm tied up in meetings in DC the rest of the afternoon, so please reply to all for timely responses from us. Thanks,
