Meeting with Ellen Kullman, Chair of the Board & Chief Executive Officer of DuPont

Ellen J. Kullman
Chair of the Board & Chief Executive Officer

Ellen Kullman, 55, is chair of the board and chief executive officer of DuPont. She is the 19th executive to lead the company in more than 208 years of DuPont history.

Ellen became CEO on Jan.1, 2009, and chair of the board on Dec. 31 that year. She was president from Oct. 1 through Dec. 31, 2008. Prior to that, she served as executive vice president and a member of the company's office of the chief executive.

As CEO, Ellen has championed market-driven science to drive innovation across the company's businesses. Under her leadership, decision making has moved closer to customers around the world, resulting in greater partnering, collaboration, and solutions attuned to local needs.

A native of Wilmington, Del., Ellen began her career at DuPont in 1988 as a marketing manager. She served as business director for several businesses including White Pigment & Mineral Products where she became vice president and general manager in 1995. She assumed leadership of two high-growth businesses, DuPont Safety Resources in 1998 and Bio-Based Materials in 1999. She was named group vice president - DuPont Safety & Protection in 2002. In 2006, she was named executive vice president with responsibility for three business platforms and several functions including Marketing & Sales. In 2008, she was tapped to lead the company's focus on growth in emerging international markets.

She is a member of the U.S.-India CEO Forum, the Business Council, and the executive committee of SCI-America. She is co-chair of the National Academy of Engineering Committee on Changing the Conversation: From Research to Action.

Ellen is a member of the board of directors of United Technologies Corp. She also is on the board of trustees of Tufts University and serves on the board of overseers at Tufts University School of Engineering.

Prior to joining DuPont, Ellen worked for General Electric. She holds a bachelor of science degree in mechanical engineering from Tufts University and a masters degree in management from Northwestern University.

BACKGROUND:

Capital investment: \$500 million

Job total: 1,700 over 10 years; includes 80 new jobs at the company HQ in Fort Mill (Lancaster County).

First phase: brings the plant's production capacity to 5 million tires per year by 2017

Second phase: brings the plant's production capacity to 8 million tires per year by 2021

Plant: Site covers 330 acres; building is planned to be in excess of 1 million square feet.

Construction to begin in mid-2012.

Tires: Will be produced under both the Continental and General brands. Will produce for both replacement tire market and automakers.

South Carolina operations:

- Operation in SC called Continental Tire the Americas LLC. It is the HQ for Continental tires in the Americas – including Mexico and Brazil.
- The HQ moved to MacMillan Business Park in Fort Mill (Lancaster County) from Charlotte. The move was announced in Feb. 2008 and completed in early 2009.
- At the time of the move, the op was called Continental Tire North America, but

name changed in 2010 because of company growth in South America.

- Continental also used to have production in Charlotte.
- Announced investment in 2008 was \$11 million for land and the new 75,000-sq-ft facility. The HQs has about 375 employees.
- Continental used to have ops in Blythewood and Columbia that now house Pure Power Technologies.
- Continental in Fort Mill has donated "\$35,000 to the Lancaster County schools. In addition, the company has given 350 tires to the county for use in its police, fire and municipal vehicles. Altogether, the donations are valued at nearly \$100,000." (May 2010)

Also of note:

Schaeffler Group, which has several operations in S.C., owns a chunk of Continental AG. As of March 2011, Schaeffler held 60.3% of Continental . Maria-Elisabeth Schaeffler is on the Supervisory Board of Continental AG.

More about the company:

Continental Tire the Americas, LLC (CTA, formerly Continental General Tire) is a subsidiary of Continental AG. CTA acquired General Tire in 1987.

CTA employs 9,000 employees. Continental Tire has six locations throughout the Americas:

- Fort Mill, SC; Mount Vernon, IL; Mississauga, ON; San Luis Potosi, Mexico; Camacari, Brazil; Quito, Ecuador

These manufacturing plants produce one-third of the Continental Corporation's total passenger and commercial tires. Continental is a major supplier to the original equipment and replacement tire markets, selling Continental, General, Euzkadi and private brands in NAFTA. Sales in North America include:

- Passenger, Original Equipment 25%
- Passenger, Replacement Business 34%
- Private Brands 5%
- Truck Tires 29%
- Farm and Earthmover Tires 5%
- Other 2%

CTA supplies passenger car tires to original equipment customers that include BMW, Ford, General Motors, Mercedes-Benz, Nissan, Toyota and Volkswagen. Commercial vehicle tires are delivered to Caterpillar, John Deere, Freightliner, International, Ford, Mack and Volvo.
