We did close the line early on Monday as we did not think we would be able to timely serve everyone in line if the number was not limited- safety and security issues. This is allowable under FNS guidelines. For the remainder of the week, the line remained open until 7 PM as advertised and there were 0 persons in line at 7PM. No one was turned away on those days. We took 31,256 applications in Richland County. Please advise if further information is needed.
