Dear Melanie Giese,

I am a dialysis patient from Clemson, currently receiving treatment at DaVita in Pendleton, South Carolina. I am concerned about the cuts to Medicaid and the end of reimbursement for vitamins.

As dialysis patients, our diets are strictly monitored. We have to eat diets that are high in protein, low in sodium, calcium, and phosphorus. With today's economy, it is hard for many patients to afford to eat the right foods to maintain a healthy diet. Since most patients have to receive dialysis three days a week, for about four hours per treatment, being able to have the vitamins provided at no extra charge make it possible to feel better and have improved lab results. A better lab result equals healthier living and a better way of life. Without these vital nutrients that we need, I'm concerned that many patients will get sicker or worse.

It is also important to me that I have access to the best quality of care. Although these Medicaid cuts don't directly affect me personally, I'm afraid that the cuts to Medicaid reimbursement could result in my health care team leaving to find better paying jobs.

While I understand that this may be a bad time due to a tough economy, I hope you will take all this into consideration and reconsider your decision to reduce the quality of life for many of your fellow South Carolinians.
