Polk has more than 40 years of experience in fire and emergency services, and has most recently served as the Fire Chief for the Pinellas Suncoast Fire & Rescue District in Florida. Currently a resident of Columbia, S.C., Polk previously served as South Carolina’s Fire Marshal under Governor Jim Hodges from 2000 to 2003.
