(Exit 65 off of I-77) Purpose: Partnership with Truvista to offer internet access "parks" to parts of Chester County who currently have no access to internet for students in the school district. As far as the school district administrator knows, this is not being done anywhere else and this could be replicated in the other very rural areas of our state. This may not sound like a big deal to those of us working in Columbia; but to a rural and high poverty area like some areas in Chester, it is a big deal. Things that we take for granted are "super-size" deals for many. This is one of those deals. It will offer pocket communities who currently have no access to internet an opportunity that they have thought impossible. Could someone from Gov. Haley's office come for this event?
