

HOUSE CONCURRENT RESOLUTION NO. 43

BY REPRESENTATIVE EDWARDS

A CONCURRENT RESOLUTION

To recognize November 13, 2013, through November 11, 2025, as the commemoration of the 50th Anniversary of the Vietnam War.

WHEREAS, in observance of the 50th Anniversary of the Vietnam War, it is important as a nation and state that we reflect upon the valor of a generation that served with honor and although long and controversial in nature, this war in many ways defined an entire generation of Americans; and

WHEREAS, although American involvement in the conflict of Vietnam spanned several decades and presidencies, the ground offensive officially began in March of 1965, with the deployment of 2,500 Marines and by the end of that year, nearly 200,000 American troops were in Vietnam. The strength of the Allied Armed Forces peaked at 543,482 troops during the Vietnam war; and

WHEREAS, we draw inspiration from our Louisiana heroes who suffered unspeakable tragedies. Approximately 153,303 veterans suffered nonmortal wounding, 14 were held as Prisoners of War, and 24 remain unaccounted for; and

WHEREAS, by the official end of the Vietnam War in April of 1975, nearly three million American servicemen and women had been on the ground, in the air, on the rivers, and at sea within Vietnam's borders serving in some capacity during the conflict. As a grateful nation, we honor more than 58,000 patriots who paid the ultimate sacrifice during this difficult and painful period; and

WHEREAS, of the 7,391,000 Vietnam veterans, the United States Department of Veterans Affairs estimates that roughly 106,148 reside in Louisiana. In the half century

since the official beginning of the Vietnam War, our nation has grappled with the sensitive effects of this struggle which accompanies all wars. Yet, we remain thankful to those who fought in this conflict and honor the legacy of service that they built; and

WHEREAS, the freedom and liberties we are blessed to enjoy today are a direct result of the courage, devotion, and sacrifice of the members of our Armed Forces. We are grateful for their brave service and draw inspiration and pride from all that they are.

THEREFORE, BE IT RESOLVED that the Legislature of Louisiana hereby recognizes November 13, 2013, through November 11, 2025, as the commemoration of the 50th Anniversary of the Vietnam War.

Thank you for writing. I appreciate hearing from you.

When Americans answer the call of duty to serve in our Armed Forces, a sacred trust is forged. Our men and women who have served in the uniform of the United States of America risked their lives to protect our freedoms. Beginning at enlistment, we must do everything in our power to support and provide them with the benefits they have earned. Our Nation's first President understood this obligation—as I do—to be “a debt of honor.”


My Administration is working every day to fulfill our obligation to our heroes. Last year, I signed the American Recovery and Reinvestment Act, creating tax incentives for businesses that hire unemployed veterans and providing one-time payments to eligible veterans totaling \$700 million. My 2011 Budget builds on last year's historic increase in veterans funding, and extends employment and training services to our veterans to help them during our Nation's economic recovery.

We have taken additional steps, extending health care coverage to an additional 500,000 veterans by 2013, increasing access to rural medical care, easing the transition from military care to veterans' care, and enhancing screening and treatment of Post-Traumatic Stress Disorder and Traumatic Brain Injury. We are building a 21st-century Department of Veterans Affairs and harnessing technologies to cut the red tape and fight the claims backlog. We implemented the Post-9/11 GI Bill so more service members and their families can pursue higher education and reach for the American Dream. I am in receipt of your letter to Governor Brian Sandoval dated November 4, 2012, and regarding Vietnam veterans suffering from environmental health hazards. Thank you for taking the time to engage on this important subject. I hope my response here is of some help. Commence

As you may know, the Department of Defense is beginning their commemoration of the 50th anniversary of the Vietnam War next year. The purpose of this commemoration is to thank and honor veterans of the Vietnam War for their service and sacrifice, to highlight the service of the armed forces, to pay tribute to the contributions made on the home front by the people of the United States, to highlight the advances in technology, science, and medicine related to military research, and to recognize the contributions and sacrifices made by the allies of the United States during the Vietnam War. It will be carried out over two years leading up to the 50th anniversary through local events held around the nation in support of the DoD effort.

Our agency is proud to partner with the Nevada National Guard to honor the veterans of the Vietnam War and their families through this program next year. We are currently developing our plans for a program for Memorial Day on May 27, 2013, so I appreciate your recommendation for a Governor's proclamation. We will work to see if it can be included in the event's program.

Thank you again for engaging in this matter, and thank you for your service.

Local Vietnam Vets want parish council to support resolution honoring veterans of Vietnam War

AMITE -- Two Vietnam veterans asked the Tangipahoa Parish Council to use its influence in support of a resolution honoring veterans of the Vietnam War.

Marine veteran Marvin Vernon and Navy veteran Norman Alkazin, both of Amite, asked the council, at its April 27 meeting, to approve a resolution asking the Louisiana Congressional Delegation to support a declaration in Congress recognizing those who served in the war.

Vernon thanked the council for its past support of veterans and veterans' issues.

"It hasn't gone unnoticed," he said.

He said many Vietnam veterans are dying daily, and it is important to honor them for their service while they are living.

Alkazin said the council has been a leader in standing for Vietnam veterans. He asked that the council especially request support for the Toxic Exposure Research Act, which would benefit all Vietnam veterans exposed to toxic chemicals such as Agent Orange.

Councilman Harry Lavine said many people do not realize the sacrifices that Vietnam War veterans made for their country.

Councilman Nicky Muscarello Sr. said the council thanks the veterans for their service.

"We admire you guys," he said.

The resolution to the Congressional Delegation was approved.

Councilman Louis Joseph told the council that parish President Gordon Burgess was recently recognized by the state Legislature for his exemplary service to the parish.

Joseph said the Legislature noted that Burgess implemented the pay-as-you-go funding plan for the parish, and provided services and public improvements over the years without putting the parish in debt.

"He leaves a legacy of exemplary public service," Joseph said of Burgess, who is retiring at the end of the year.

Burgess said it was the people, employees and council members who made his 30 years of service a success.

"I'm honored to have had the opportunity to serve," he said.

Fallen Amite police officer honored in Washington

A murdered deputy marshal will be honored in Washington DC on May 13 at a Candlelight Vigil.

Deputy Marshal Limus Walter Amite Police Department was beaten at the age of 41 when he intervened in a men burglarizing a pharmacy sustained major head injuries and died.

Moak had served with the Amite Police Department for nine years. At his funeral he was survived by his wife and three children.

can't be published in this article, but remember it was a long time ago and we were young and growing up when the Cave was the place to be.

Letter to the editor Tangipahoa Parish cares about veterans

You have been kind in the past concerning veterans' issues I have involved myself with. I thank you! I would like to share with you and your readers a recent milestone success. This also applies to those having an interest in efforts to recognize Vietnam War veterans for their services.

In April in the legislative session, a resolution by Rep. John Bel Edwards was introduced and adapted recognizing the 50th year anniversary of the Vietnam War, as well as the tragedies and sacrifices of these armed service members.

An attempt in 2012 to recognize these men and women veterans had failed. This resolution, La. 2015 #43, followed the example of the people of Florida in 2005 with U.S. House Resolution

Our Tangipahoa Parish Council last month, with Mr. Greg Varnado and Mr. Louis Joseph, sponsored a resolution R15-#28 adopting La. House Resolution 2015-#43, to be forwarded for consideration to Louisiana's U.S. Congressional delegation. These resolutions were to be presented to the U.S. Congress as a resolution to honor and recognize our Louisiana armed service men and women who served in the Vietnam War and its 50th year anniversary.

It is important for the citizens of Tangipahoa Parish to know about these patriots who represent us as elected delegates. Their action on behalf of these veterans is not only honorable but also is an

example that Tangipahoa Parish truly cares for its armed service men and women.

Another matter of interest is the current legislation before the U.S. Congress (The Toxic Substance and Research Act) that needs supporting by the citizens of Louisiana.

It should also be noted this legislation will apply to all armed service members and their progeny harmed from toxic substances while in service.

In addition our Louisiana congressional delegates should be encouraged to adopt La. Resolution 2015-#43 in the U.S. Congress on behalf of its Vietnam War Veterans and the 50th year anniversary commemoration.
