Elected Officials,
My name is Joshua Gentry and I have been a resident and taxpayer of Anderson County for 27 years of my life. I am a young successful banking executive with a wife and 2 small children. (Anna- Ryleigh 7 and Emma- Leigh 4) Recently, my families lives have been put in danger and my personal life has been violated. We started recieving numerous threats from an individual and have filed 3 police reports. (2015-04191, 2015-04457) All police reports were filed with Anderson County. The individual has made numerous threats to myself, made

numerous calls to my place of employment and today followed my wife into town and scared her beyond words. The Anderson County Sheriff's department issued a warrant for his arrest on 2/21 and Corporal Huff will be seeking another one tomorrow for the continued threats. The individual in question is Christopher McNeill. An individual who was charged with theft and neglect of an elderly woman here in Anderson County. This individual has been out on the streets continuing to cause trouble. My issue is the deputies have been aware NUMEROUS times over the course of the past few days and Mr. McNeill is STILL not detained on the charges. Now how is it that a person continually breaking the law is never arrested when the sheriff's office knows exactly where he is and has an active warrant. My wife went to the Anderson County Magistrate office today located in Powdersville SC to file a restraining order in an attempt to have some sort of immediate protection plan in place. Once she filled out the proper paper work the Magistrate Judge, Tommy Tucker, stated that he "would not sign off on the restraining order" due to the fact that he and his parents attend church with Mr. McNeill's parents and that it would have to be sent to a different judge. Again, delaying the process even more. Our daughters are staying with a relative currently as we fear for their well being. Now with that being said Mrs. Haley, as Governor, would it be a conflict of interest for you to push Amazon out of SC because you sit next to EBAY's CEO in Sunday school? I do not feel protected, my rights as a tax paying citizen continue to be avoided and my families' lives and well being are at stake. I have numerous witnesses that have provided statements and yet nothing has been done. Mr. McNeill could walk up to us at any point in time and end our lives. The question here is what will you all do to resolve this and protect a citizen of your County and State? This email will be forwarded to the following:
