Aiken Standard: DOE yet to release report on projected MOX cost

Officials said the Department of Energy say they will release a study that projected the life-cycle cost for the Savannah River Site's MOX program to be \$30 billion. However, there has been no word on when the study will be made available.

Note: After news surfaced that DOE conducted the study, Gov. Nikki Haley, U.S. Rep. Joe Wilson, R-S.C. and a host of other individuals and organizations have asked to see the study, and have also asked why the information has not been made available sooner.
