Grant Application Synopsis - Best Chance Network

Collaborations with key external partners, such as SC DHHS, continue to be crucial to the Best Chance Network's plan for the next five-year funding cycle. We will be working with partners to provide specific and appropriate screening promotion activities to increase the reach of the program beyond women screened with CDC funds, inform policies that support screening and assure quality, make health care system improvements, and implement other data driven, evidence-based interventions to support organized screening efforts.

Specifically, the purpose of this funding period is to transition the Best Chance Network, a highly-functional public health infrastructure for cancer prevention and control, into new roles and functions to anticipate South Carolina's needs in the years to come. The goals are to (1) seek efficiencies across the management and operations of cancer prevention and control programs, (2) focus on high-burden cancers with evidence-based, scalable interventions that already exist and can be broadly implemented, (3) develop organized screening programs that are more effective and efficient than current opportunistic approaches, and (4) maintain high-quality cancer registries and expand their application in prevention and screening.
