Ok - Here is another stab at what I think is a great program.

I've attached the program and an updated script. The script has times included but not the running times yet. It needs some cleaning up in terms of format and tweaking of the script but I wanted you to see how it flows.

It adds up to around 56 minutes with the Governor speaking for 4 minutes so there is still some breathing room. Please review my addition of times to see if you get the same thing!

I've moved a few things around but I think this gives us a better flow and a more dynamic program.

I added the bells back in for a couple of reasons -

1. Their second piece is only 2:15 so it is short and I know they would be crushed if we didn't have it as part of the program. She promises it is dynamic.

2. We have the time.

They can still play as people leave if we want that.

We've got 4 sing alongs for the audience during the program that includes a song that the Hallelujah singers will invite folks to sing.
