Does the statute for the Juvenile Parole Board need to be changed in order for them to change the number of members required to have quorum?

SECTION 63-19-630. Officers; rules and procedures.

The parole board shall elect from among its members a chairman who shall serve a one-year term and who may not succeed himself as chairman. The parole board may elect a vice-chairman and secretary and shall fix the time and place of meetings. Rules and procedures for parole board meetings, as considered advisable, must be adopted by the parole board. Six members of the parole board constitute a quorum for the transaction of business.

I am Toni Vanlue, Director of the SC Board of Juvenile Parole. I am contacting you regarding an issue that our Board has been trying to resolve for quite some time now. In state statute our quorum is six members (please see below); however, that is from a time period when we had 10 appointed Board members; we now only have 7 appointed Board members and need to have the quorum changed. What steps can I take to address this issue? Thanks for your time.
