"We have constituents who see waste, and they want to tell someone about it," said Gov. Haley. "We have state employees who see fraud and abuse, and they want to tell someone about it. Now, they have a phone number to call toll free and someone to tell – our Inspector General – who will take action to investigate it."

Last month, Gov. Haley created by executive order the position of State Inspector General and named George Schroeder as the first appointment to this position. The State Inspector General is charged with detecting, exposing and deterring fraud, waste, mismanagement, and abuse in programs and operations of executive agencies.

Dear Attorney General Wilson,

Please consider this letter as a formal request for an opinion from your office regarding the legality and constitutionality of provisions of South Carolina Code of Laws Sections 23-9-310 through 23-9-470 pertaining to the Office of the State Fire Marshal and specifically Article 3 which deals with the Fireman's Insurance and Inspection Fund. Do these provisions violate the Constitution of the State of South Carolina and its subordinate laws? Certain provisions of this Article require:

- a. Section 23-9-370 requires fire departments be members of the S.C. State Firemen's Association to participate in the fund.
- b. Section 23-9-430 requires the county treasurer to pay 5% of the 1% tax on fire insurance and the S.C. Firemen's Association.
- c. Section 23-9-370 allows the S.C. State Firemen's Association to supervise and inspect the operations of the ordinance.
- d. Section 23-9-450 requires written approval from the S.C. State Firemen's Association as to the manner and method of the disbursement of funds from a fireman's insurance and inspection fund.
- e. Section 23-9-470 prohibits an agency of the state including the Budget and Control board from reducing the amounts required to be distributed to counties and municipalities.

These provisions raise concerns about state funds being paid to a lobbyist's principal, the transfer of public funds to a private association, and potential violations of the State Procurement Code, S.C. Code 11-35-10 et. seq.

Hey Scott,

A few days ago, Scott Ramsey and Jon Castro came to my office and asked if I would helping them with a financial matter.

The following is the situation for which I am sending to you for review and consideration. I can certainly sit down with you at your convenience to explain in further detail.

As you know, SCsDB receives Medicaid reimbursements for the services provided to the students (i.e. physical therapy, occupational therapy, etc).

At the end of the year, there is a cost reimbursement opportunity for agencies to request the difference for which they were actually reimbursed and the amount for which they were entitled.

SCsDB would like to contract with the former Director of Health & Human Services to help expedite the process of SCsDB getting their cost reimbursement. However, SCsDB cannot enter into a contract of any kind without going through the State's Request for Proposal process and bidding it out.

The contractor has agreed to facilitate the tasks of the contract for 10% of the reimbursement amount that he is able to secure for SCsDB (estimated \$650,000).

SCsDB is asking that The Walker Foundation be the holder of the contract which would keep SCsDB from having to bid out the contract. I have a copy of the contract for you to review. This mechanism is not under the table nor illegal, as Clemson Foundation and USC both hold similar contracts for this same purpose.

I indicated to Scott Ramsey and Jon Castro that The Walker Foundation would look into the feasibility of us holding the contract for a "fee".

I wanted to see if I could drop the contract off at your office next week and leave for you to review and then you can share your thoughts with me regarding this request from SCsDB.

Let me know your initial thoughts.
