In addition, Kristen Blanchard and her husband Jim Blanchard attended the Inaugural Gala in Columbia on January 14, 2015 and had a photo with the Governor and her husband.

COMPANY OVERVIEW: Nutramax Laboratories was founded in 1992.

- Nutramax, a family-owned company researches, develops, manufactures, and markets nutritional supplements for people and their pets primarily in Maryland and South Carolina through its two business divisions, consumer products and veterinary science.
- The company offers products in the areas of joint health, heart health, brain health, liver health, and wellness of people, dogs, cats, horses, and rabbits. It also offers amino acid-based biofertilizers for enhancing the health and wellness turf grass; and to treat non-sports plants, such as pumpkins, avocados, and cranberries.
- The company sells its products through retail and online stores.
- Nutramax's product Cosequin, a joint health drug, is endorsed by Jack Hanna, celebrity director of the Columbus Zoo who has appeared on the Late Show with David Letterman, the Ellen DeGeneres Show, Entertainment Tonight, Fox News and

CNN.

- Some of the Cosequin Joint Health drug competitors are GNC Pets, 21 Century (Manufactured in Tempe, Arizona) and The Missing Link, headquartered in Valencica, CA.
- In 2010, the company announced its plans to locate Nutramax Laboratories and Nutramax Manufacturing in the state, investing approximately \$29 million and growing to 250 employees. It opened Nutramax Laboratories Veterinary Sciences, Inc. in Lancaster, South Carolina, and that facility is used to research and develop products to support animal health. Currently, Nutramax employs 283 full time employees in South Carolina, per Kristen Blanchard with Nutramax.
- Per Ted Campbell, the company purchased the former U.S. Textile plant, and plans to invest \$15 million over the next 5 years as well as creating 125 new jobs, 33 of which have already been hired. When the relocation is complete, the company will have three sites in Lancaster County – Nutramax Laboratories and Nutramax Manufacturing, both located in Lancaster Business Park. The 946 building where the event is being held is used for manufacturing, quality control, warehouse/distribution and corporate headquarters. 851 quality drive is customer service and our soft chew manufacturing. The new building 1759 Flat Creek is still being rehabbed. But it will be Nutramax's warehouse and distribution center along with soft chew manufacturing and offices by the end of this year. We will then be expanding manufacturing in 946 building.
- According to the Baltimore Business Journal in 2012, the original plan in 2010 was to move the Edgewood-based consumer division and manufacturing operations to SC as well, however, per company spokeswoman Lisa Beck at the time, company growth necessitated both locations.
- The company is headquartered in Edgewood, Maryland, with plans to relocate to Lancaster, S.C.

Background: Megan messaged NH through social media on Friday, January 15th; Becca called her that afternoon and spoke for a few minutes; Since then, they have texted/talked a few times.

About Megan: She is a very polite, soft-spoken, and mannerly on the phone; She is very open and not shy about discussing what has happened to her; She is very thankful that the Governor cares about her; She says she doesn't do much on the weekends – she stresses about school and sleeps a lot; She refers to the bullying incidents as "drama".

Megan's Family: Megan's parents are Sonya and Brian. She has one sibling, a brother who is five years older. She is close with her grandparents.

School Activities: Megan used to play in the band, cheer, and play soccer, but she has quit or gotten kicked off all of the teams due to the drama with certain boys and girls. At this time, she is not involved in any organizations or extracurricular activities and is trying to get her grades up that have suffered due to the bullying drama.

October Incident:

- Last October, Megan was at Dunkin Donuts with classmates before a late-start at school;
- Two boys (one in 9th grade and one in 10th grade) threatened to beat her up and ruin her life and also sent threatening messages via social media;
- She has known both boys for a few years and also has been friends with the boys' girlfriends, meeting all of them in middle school after having been homeschooled for elementary school;
- After the episode at Dunkin Donuts; Megan immediately went to the front office and met with the vice-principal to tell what had happened;
- Later that day, Megan told her grandparents, and her grandfather filed a police report on each boy;
- She also met with Principal Greg Morton who told her he would not be able to do anything, because the incident happened off school grounds, but he said he would tell the boys to be careful about what was posted on

social media;

- Megan has also told a trusted teacher about the bullying, has met with the vice-principal, and has met recently started meeting with a therapist/counselor;
- Megan continues to see the two boys every day at school, since they all have classes in the same tech building;
- Megan will be bringing the police files and other files with the school that she will bring to the meeting.

Purpose of the Meeting:

- For NH to share her own story about being bullied;
- For NH to tell her about her anti-bullying tour and visiting schools (Cool Kids Don't Bully);
- To ask Megan about her story and what NH could do to help her.
