Val and Annie,

I have good news! The letter that you sent this afternoon will work. It only needs one very slight change. In the paragraph about the rumor, the time period they heard was 90 days, not 30 days. Given that such period is not required by statute, I didn't think it would be a problem to change. So if you could make this change and then forward an executed copy, that would be great.

I have explained in my email to the Volvo rep, the possible penalties if someone does not get a license once they are a SC resident.

Below is language from the email from the Volvo rep that I wanted to pass on:

On the topic the feedback from those that went through the process of getting a SC driving licenses have very good experience from dealing with the Ladson DMV office. We have been very well taken care of and they are supportive with the administration required which is very helpful. If you are able to forward this feedback to DMV we would be grateful.

Thanks to all of you who helped to resolve this issue!!! The Volvo representatives intend to recommend that all

of the reps and their families obtain a SC license, but this letter has relieved a lot of stress and has allowed them to focus on the more important tasks at hand.
