FTA, in partnership with The National Center on Senior Transportation (NCST), invites applications for a new Ladders of Opportunity Grant Program — *Connecting Seniors to Public Transportation*. This competitive grant program will provide funding to communities to develop and test interventions designed to encourage and facilitate increased access and usage of public transportation and mobility options by older adults to support successful aging. Funded projects will be required to partner with one of several national initiatives that support aging in place and currently operate in numerous local communities nationwide. Grants will be awarded to 5 communities at a maximum of \$20,000 each for approximately 5 months. Proposals are due Nov. 7, 2014.
