It is an honor to serve the people of the Second Congressional District of South Carolina. My office recently received constituent concerns which I feel you may find relevant. Please allow me to share these concerns below:

*My stepson\* has special needs and has developmental delays and is in constant need of medical care. He is currently being serviced by The ARC of SC. I am now and always have been extremely happy with their service coordination. It has come to my attention that the SC Dept of Health and Human Services has determined FOR US what the ARC is going to be allowed to provide under service coordination. I understand that these changes will in fact affect even private providers like the ARC of SC to include: increase in case load, extreme limitations (no more assistance w/IEP meetings, benefit assistance like TEFRA, SSI, ect). So many parents are not able to handle the IEP process or know their rights in regards to their disabled children! THIS ASSISTANCE IS CRITICAL!*

*If it hadn't been for the service coordination efforts of the personnel at the ARC of SC, my son would not have some of the services he now receives. My wife and stepson moved here from Mass 4 years ago and had to start the "get on the list for services" all over again after 17 years. My family needs quality access to our service coordinators. People with disabilities require ADDITIONAL SUPPORT AND ASSISTANCE as compared to the other Targeted Case Management populations.*

*These changes will be DEVASTATING to the service delivery system and more importantly, to all of the incredible people with disabilities.*

*This is URGENT! Please don't cut services from the people who need them the most---the disabled!*
