BLUF: CNN suggests we are one of four states “pending review” on our ability to use our Driver’s License as a source of identification for boarding airplanes next month. It would appear that CNN is not reporting the most “recent” updates. According to the DHS website with a “last published date of December 29, 2015”, Alaska, New Jersey and South Carolina have extensions until October 10, 2016. California is the only state still under review for an extension renewal. See attached copy of our extension. The DMV has received several constituent questions on the story, but nothing we have not been able to handle. We can either provide a press release with the facts or let this one fade into the ages.
