Draft Amendment – See attached.

Talking Points (rationale):

Stakeholders from the medical community (Governor's Prescription Drug Abuse Prevention Council) would like to amend the bill to limit prescriptive authority just to hydrocodone, not to all Schedule II controlled substances.

If the intent of the bill is to allow the specific drug (hydrocodone) to be prescribed, then the specific drug should be named. As written, this bill does more than that.

Written as is, the bill would open up the entire class of Schedule II drugs by statute, not just by regulation. It is unknown what other highly abused medications may be reclassified as a Schedule II drugs in the future.

Prescription drug abuse is a serious issue in South Carolina, and the authority to prescribe these types of highly addictive controlled substances should be narrowly limited.

Limiting prescriptive authority to hydrocodone by name will allow the current practice of optometry to continue without interference and will safeguard the public from potential abuses.
