Works with U. S. Forest Service law enforcement, industry security agents, as well as local law enforcement. Primary victims are the elderly, minorities and absentee landowners. Title 48-23-90 Personnel involved in these activities also support the agency's wildland fire suppression effort during periods of high fire activity and on large and extended attack fires.

Identification and prosecution of persons committing forest products theft and fraud and other criminal acts related to timberland and its uses. Reduction in the number of theft and fraud cases over time and/or the monetary loss associated with those cases. Outcome Measures:

Aggressive enforcement appears to be having the desired crime prevention effect. Reports of theft/transaction crimes were approximately the same level as last year. During the year agents investigated 160 cases valued at approximately a half-million dollars. With approximately 23% of wildfires being arson related, agents focused on investigation of serial woods arson cases this year. Even though woods arson is an extremely difficult crime to prove, seven investigations involving 45 fires resulted in five arrests. All agents are fireline qualified; all participated in fire suppression, fire investigation and fire law enforcement efforts during the year.

New forest resource data is on schedule to be released in July, 2006. The SCFC is leading an effort, in cooperation with the USFS and NC State, to study the long-term availability of our wood resource. This study will help determine opportunities for industry recruitment. 14 active projects in FY '05-'06 were focused on developing new markets for forest products. Capital investment by forest products companies exceeded \$570 million and 455 jobs.

Expected Results:

Marine Shellfish populations remain sufficient to provide commercial and recreational harvesters a reasonable opportunity to harvest abundant, high-quality shellfish species and shellfish resources provide sufficient habitat for other marine species. .

Outcome Measures:

During 2005, 95,954 bushels of oysters and 21,212 bags (~250 count) of clams were harvested commercially for a value to the harvester of \$2.4 million. Approximately 40,000 shell fishermen participate in the recreational fishery each year, harvesting on 26-state-maintained public and state shellfish grounds used exclusively for recreational harvesting. These public grounds are planted with shell to repopulate the areas on a rotating basis; in 2005, 46,620 bushels of oyster and whelk shells including 10,494 bushels of recycled oyster and whelk shells were planted at eight locations. Additionally, recycled shell from the public at sixteen department-maintained, recycled shell drop-off locations. Commercial hard clam aquaculture industry landings are estimated at over \$5 million.

Population numbers and catch rates of targeted marine finfish remain sufficient to provide both resident and nonresident recreational and commercial fishermen a reasonable opportunity to successfully catch desired fish.

Fish resources remain in good overall condition as represented by red drum, which remained the most targeted inshore marine finfish species. Although populations can fluctuate as a result of environmental conditions, catches of red drum remained very near the long term average with approximately 537,669 red drum being caught by S.C. recreational anglers. The DNR continued to maintain 45 artificial reefs, adding 3 boas, 2 barges, over 3,500 pieces of material, 50 steel shipping containers and over 100,000 ton of bridge concrete. An estimated 80,000 + fishing trips are conducted annually by private and charter vessels generating over an estimated \$25 million.

Expected Results:

Population numbers and catch rates of targeted crustaceans remain sufficient to provide both recreational and commercial fishermen and tourists a reasonable opportunity to successfully catch targeted crustacean species.

Outcome Measures:

Shrimp stocks remained relatively healthy compared to long term indices. However, 2005 commercial landings were below the long-term average. During 2005, about 2.53 million pounds of headed shrimp were landed by commercial vessels worth about \$6.4 million. Total value was substantially below the long-term average due in part to weak unit prices symptomatic of increased imports. Permit sales for the shrimp baiting fishery were 9,004 in 2005, the lowest since 1988 and 1989. Effort was at an all time low in 2005 with just over 31,000 trips. The estimated recreational harvest was 0.704 million pounds heads-off. Commercial landings of hard blue crab in 2005 totaled 4.36 million pounds, below the long term average but consistent with landings since 2002. A slight drop was seen in value from the previous two years at \$3.44 million. The decline in total catch is related to reduced

The state park system includes 46 operational parks and eight historic properties. State parks, and the state overall, have a solid foundation on which to build the future of South Carolina. Through state parks, South Carolina can: enhance and build a park system that is representative of the state's intrinsic character; improve a recreational and educational framework that already serves upwards of 9 million visitors annually; stimulate new economic development initiatives through tourism; and project South Carolina's singular quality of life. The investigation of fish mortalities will lead to a better understanding of their cause and prevention and in selected cases provide the State with a means of mitigating the resource loss. The result of habit enhancement and rehabilitation is an increase in fishing opportunities available to the angler. Additionally, some of these areas should provide nursery habitat to enhance survival and recruitment of reproduction.

Outcome Measures:

Freshwater fishing in South Carolina has an economic impact of over \$717 million annually. South Carolina maintains approximately 450,000 licensed anglers. A survey on South Carolina's licensed anglers indicated that 82% are satisfied with the performance of the Freshwater Fisheries Section. A survey of South Carolina's general population shows that, while 35% of the population does not know enough about SCDNR to rate its performance, 52% feel SCDNR is doing a good or excellent job managing the State's fishery resources. Approximately 130 lakes, reservoirs, rivers and streams are surveyed and inventoried annually. Habitat enhancement activities and fish concentration areas are maintained at 145 sites. Environmental permits are reviewed for approximately 27 projects and approximately 28 fish kill events are investigated on an annual basis.

The agency also serves in a support role with EMD and SLED for all risks incidents, such as hurricanes, etc. \$171,000 of Volunteer Fire Assistance federal funds are passed through to Volunteer Fire Departments through a competitive grant system. Expected Results:

Firefighting response priorities are: protecting life; protecting property; and protecting natural resources. Wildfire response personnel, including detection resources, reconnaissance resources, support resources, and suppression resources maintain a threat-appropriate level of readiness, with readiness increasing as wildfire danger escalates.

Outcome Measures:

A quick response on initial attack with properly trained and well-equipped firefighters is essential to keep wildland fire losses to a minimum. A below average fire season enabled the agency to effectively handle calls despite a 13% vacancy factor among initial attack firefighters. During FY 06, 3,021 fires burned 16,295 acres compared to the five-year average of 3,371 fires burning 21,945 acres. Average response time decreased over 2 minutes, to an average of 32.4 minutes, but still above the agency's goal of 30 minutes at full staffing. Average acreage burned per fire was 5.4 acres, well below the five-year average of 6.5 acres. The agency has expanded personnel assignments and training for serving on all risks Incident Management Teams.

Monitors all forest land within the state for outbreaks of serious insect pests or diseases including Southern Pine Beetle, Hemlock Woolly Adelgid, Gypsy Moth, exotic bark beetles, Fomes Annosus, Sudden Oak Death, etc. Works with landowners, forestry professionals, and other state and federal plant professionals to implement management strategies that minimize risks of outbreaks. Detects infestations through the use of aerial and ground survey methods including public reporting. Advises and coordinates with other professionals emergency response measures for control when necessary. Title 48-23-90, 48-29-20 Personnel involved in these activities also support the agency's wildland fire suppression effort during periods of high fire activity and on large and extended attack fires.

Number of impacted areas identified and size minimized. A statewide 20% aerial survey was conducted to identify impacted areas, with additional periodic reconnaissance's flown in targeted areas; worked cooperatively with USFS, APHIS, and Clemson on identifying and monitoring exotic insects and diseases. The Red Bay Asian Ambrosia beetle was identified in Colleton, and Hampton Counties and a multi-agency investigation continues. Oak Wilt was identified in Lexington County. The Southern Pine Beetle Prevention Program, which encourages landowners to implement forest practices that minimize the effects of Southern Pine Beetle outbreaks, was implemented.

The SERCC responds to user requests, provides access to and hosts climatological databases and on-line information, and maintains contact with users. It develops automated climate monitoring products, such as KBDI, Tropical Storm Tracking, and a suite of graphics for temperature and precipitation data for the Southeast. Work continued on the Southern AER (Atmospheric Education Resource) with a quarterly publication. Collaboration continued with USC and Clemson University as well as other academic resources with SC and the Southeast. It will participate in a RCC/NCDC/NOAA deployment of the ACIS system to ingest and deliver climate data to Southeastern data users. The SERCC will also participate in the NCDC NES Pilot Study, sending two representatives for training.

In such a format, a variety of media (i.e., e-mail, CD, or printed-upon-demand hard copy) can then be used to disseminate information rapidly to stakeholders, private industry, and other government agencies. Derivative products also are placed in that format to maximize available resources.

Outcome Measures:

During FY06, 88 different economic projects requested geologic information about 29 counties. New maps covering 848 square miles were produced of the Columbia-Aiken, Lake Marion, Congaree Swamp, and Coastal areas (defined critical areas). 307 power auger holes were drilled in the 4 different Coastal Plain areas. Approximately 1,290 observations also were made where Piedmont rocks cropped out in the Columbia-Aiken map area. 14 cross sections were drawn to complement the new mapping. Outsources also produced maps covering another 193 square miles. In addition, maps covering 2056 square miles were developed into electronic products. A new, 1:1,000,000 State geology map also was produced. Three papers were presented at a Geological Society of America meeting.

Wildland fire size and potential threats are minimized by dispatching the closest available resource as identified with the CADS. All forestry related fire activity--reports of wildfires, firefighter dispatch, air operations, prescribed burning notifications, and smoke management-- are monitored, managed, and documented with the CADS.

Outcome Measures:

Forestry Commission dispatchers handled 3,021 wildfire incidents plus numerous other dispatch responses during FY 06. The dispatchers received and tracked 15,557 complex smoke management notifications representing 516,724 acres of forestry, wildlife and agricultural prescribed fires. In addition to the notifications handled by dispatchers, the automated system handled another 342,316 yard and construction debris burning notifications.

Expected Results:

Type 6 and Type 7 wildland fire engines are replaced after 150,000 miles. Medium dozers and medium transport trucks are replaced after 15 years of service; large dozers, truck tractors, and lowboy trailers are replaced after 20 years of service. Equipment is maintained and serviced according to schedule and emergency repairs and maintenance conducted in the field to minimize down time of fire fighting equipment.

Outcome Measures:

Firefighting efficiency and operator safety dictates that firefighting equipment be replaced on a reasonable and orderly schedule. Budget restrictions since 2001 have disrupted the replacement schedule. At present we have 30 medium dozers over 15 years old, 14 of which are over 25 years. With funding levels now reduced to 56% of the 1996 level of need and the price of a suppression unit having increased 51% since 1996, equipment replacement is falling further behind schedule and will soon significantly compromise both firefighter safety and fire protection effectiveness.

Accurate information regarding the availability and use of water in our lakes, streams, and aquifers must be provided to customers in a timely manner to enhance their future planning and development. High quality data are expected to be collected from monitoring stations and other sources. These data are compiled, analyzed, and disseminated via technical reports, public presentations, brochures, and the agency's web page so that sound decisions can be made at the local, county, and State levels regarding water resources. Fifteen presentations were made to water professionals and to the general public regarding our water resources, including a talk to the White House Subcommittee of Technology and Science in Washington, D.C. about the South Carolina Water Plan. Ground water levels were measured in 107 wells; surface water flows at 97 stations; saltwater intrusion at two stations; pond levels at one station; and 650 records were added to our ground water database. A ground water flow model of the Coastal Plain is being developed in cooperation with the U.S. Geological Survey. Surface water flow models are being developed for the redirection canal at Lake Moultrie and for Scott Creek at Edisto Beach. Two environmental restoration projects are being conducted to study the feasibility of restoring hydrologic conditions at the Edisto Island Causeway and at Ditch Pond Heritage Preserve. Technical assistance was provided to State negotiators for the Yadkin-Pee Dee and Saluda Dam FERC relicensing projects and to the Governor's Water Review Committee.

With South Carolina's population expanding into forested areas, creating the Wildland Urban Interface (WUI), the Forestry Commission works diligently to inform homeowners, community leaders, developers and planners in strategies for reducing the risks to wildland fire and thereby protecting their homes and communities. 90% of wildfires are human caused and 46% result from debris burn escapes. Over the past five years an average of 94 homes and structures per year have been lost to wildfire. To raise this awareness, the commission conducts homeowner and community leader workshops; develops Community Wildfire Protection Plans based on those communities assessed at high risk to wildfire; recommend hazardous fuels reduction projects to reduce hazardous fuel loads; coordinates with local fire departments; conducts smoke management workshops; investigates wildfires to determine cause and origin; enforce the states outdoor burning laws; Title 48-23-90.

Reduction of wildland fires especially those caused by debris burning and woods arson which are directly associated with risks to life, property and natural resources, with homeowners learning to fireproof their homes and surrounding landscapes and developers and planners incorporating wildfire prevention measures in new developments; increased public awareness of safe and proper techniques in outdoor burning of debris; and an increased public awareness of the outdoor burning laws. Active enforcement of outdoor burning laws adds emphasis to the fire education message. Based on individual qualifications, personnel will serve in varying capacities on the fire line or in a support capacity on an Incident Command Management Team.

Outcome Measures:

Three wildfire prevention teams were deployed in targeted areas across the state prior to the spring wildfire season of 2006 to promote safe debris burning; one team each was assigned to Berkeley and Charleston counties, Williamsburg and Georgetown counties, and Greenville, Oconee and Pickens counties. In cooperation with and the assistance of local fire departments and other cooperators, team members distributed more than 174,000 "Think Before You Burn" promotional materials to homes, businesses and public buildings and approximately 40,000 informational inserts, in both English and Spanish, were distributed through local newspapers in the targeted areas. Six "Living on the Edge" and "How to Have a Firewise Home" workshops were conducted for homeowners, developers, and community leaders, 16 interviews were conducted with local media, public service announcements were distributed to 18 radio and television outlets, debris burn demonstrations were conducted for the media by each team, and fire prevention messages were displayed on 10 billboards and 38 signs, which were placed at fire departments, recycling centers and other prominent locations in targeted communities. Team members conducted 83 burn site inspections for homeowners who were conducting debris burns. Comparing December '05 - February '06 fire data with 04-05 fire data for the same period, the percentage of wildland fires caused by debris burn escapes declined by an average of 32% in the areas targeted by prevention teams. This year investigations of
