Re: Ongoing Claims Dispute

This communication is in reference to the ongoing claim/denial/resubmittal/reapplication/research/inquiry and now secondary denial for un employment benefits initially in [October] 2016. I am providing medical documentation for the shoulder injury which I have repeatedly addressed as the ultimate reason for parting ways with the previous employer. You may use the copy of your mailing notice dated 12/30/2016 to reference this matter. While this initial injury did not occur while working with Cole, the work performed when working there nonetheless aggravated this injury, which began progressing up into the left side of the neck. One of the treating physicians, Dr. Graber, had warned that this progression could be a possibility. This work further began to affect the right shoulder also, though to a lesser degree. (This may have resulted in part from shifting more of the load from the left side to the right side of the body to reduce the strain on the left shoulder.

Despite this issue with my shoulder and other aspects of the job, I had decided to soldier on indefinitely. In fact, I had verbally rescinded my resignation which

I had unofficially given earlier (also having been done by verbal means). It was not until Deni Gore, the H.R. contact and person in charge of orientation at the North Charleston Facility, called me one or about the 15th of August and insisted that I provide the company with a firm date of separation, that I agreed to leave. She indicated that the company could not operate not knowing whether its employees were going to stay or leave. She needed a ~~date~~ final day of work. ~~Cons.~~ (I'm sure she could verify that conversation.) Considering the previously described condition with my shoulder, and not wanting to risk further injury or put my hearing ability in jeopardy, I told her to make the last day of employment the end of the month. I hope this will clear up any unclear details. This has gone on long enough. To a degree, this process reeks of fraudulent activity. Should you need further communication, please contact me immediately. I charge that you will proceed forthwith as time is of the essence.

Mr. Miller is being seen today for an initial medical visit for the evaluation and treatment of the injuries that he sustained in a motor vehicle accident on or about May 26, 2014. Patient has already been seen by our chiropractor. Patient did receive some hydrocodone in the emergency room but he is not taking had at the moment. He is not using any medication for his discomfort.

Today on the numerical pain scale his left shoulder pain is a 4/10, his left elbow pain is a 3/10, and his left leg pain is a 3/10.

Physical findings: Patient did not appear to be in any distress. He had some mild left paracervical muscle spasm, moderate left upper trapezius muscle spasm. Range of motion to his C-spine was within normal limits. Range of motion to his left shoulder was within normal limits. There is a negative left and drop arm test. Patient had some tenderness over his left lateral epicondyles of his elbow.

Assessment: #1. Cervical strain.
#2. Left shoulder strain/sprain.
#3. Left elbow contusion
#4. Left leg contusion.

Plan: Patient was given naproxen 550 mg one p.o. b.i.d. #30. He was also given formula 303 which is in natural peptic muscle relaxer before bedtime. He was given an ice pack and muscle rub for home use. He will have therapy today and will continue as per protocol. He'll be seen again for a medical follow-up in 2 weeks.

Reason for admission: neck pain, headaches, left shoulder pain, left elbow pain, and left leg pain.

Present Hx: This is a 40 year old black male who was the restrained driver of his personal vehicle when an oncoming car turned in front of him impacting the front passenger side. He stated at that time he did not feel that he suffered any life threatening injuries no broken bones or bleeding, he was taken to a nearby Roper Hospital for an evaluation. He was informed there were no internal injuries or fractures but he had suffered some contusions, abrasions, soft tissue injuries and should respond with rest and medication. The patient's accident happened on May 28-2014. He's been following home bed rest procedures for two days, he attempted to return to work on Saturday and experience exacerbation of the neck, left shoulder, left elbow pain. He presents in our office at this time requesting further evaluation.

Medical Hx: Patient has no recall of any trauma to the upper extremities.

Physical Exam/General: Patient is oriented to time and place he's cooperative.

HEENT: Fundiscopic exam within normal limits

Chest: Clear

Heart: Normal sinus rhythm

Abdomen: benign. Bowel sounds in all quadrants. Denies bowel or bladder complications

Spine/Cervical: range of motion is within normal range but is painful on the left side from C2-C5. Left upper extremities patient is tender over the insertion at the supraspinatus, he has pain over the levitator scapula and rhomboid musculature pain into the left triceps.

We have taken x-rays of the patient's shoulder for internal/external rotation make sure there is no separation of the AC junction at this time.

Assessment: I feel the patient sustained an acute mild cervical strain sprain secondary to vehicle trauma accompanying contusion and sprain of the left shoulder.

Plan: Institute conservative management for the patient at this time to include cryotherapy and ems to control pain and swelling which is the short term goal, long term goal is to make sure there are no scars, adhesions or any permanent impairment.
