Ways & Means Flood Recovery Questions

1. What impact did the flood have on your agency (operationally and the populations you serve)? What are the greater statewide implications of this impact? (This should probably be broken down to monetary and non-monetary impacts.)
2. What resources are available to mitigate flood-related issues? (\$\$-federal, state, and local; Innovative funding solutions-- nonprofits?, resource sharing, etc.)
3. What are your needs? (both immediate and long term--DIRECTLY RELATED to the impact of the flood)
4. What other information or considerations may be relevant as we assess flood-related needs? (lessons learned, procedural/statutory changes, etc.)
5. Steps forward--what is your agency currently doing to recover from the flood event and what are your plans moving forward?
