Mr. Poore called the meeting to order and Reverend Mike Vandiver gave the invocation.

On the motion of Mr. Rhodes, Council voted unanimously to approve the minutes of the April 14, 1977 Council meeting as mailed.

On the motion of Mr. Wright, seconded by Mr. Gerrard, Council voted unanimously to adopt an Amendment to Ordinance Number 2 on second reading.

On the motion of Mr. Hooper, seconded by Mr. Gerrard, Council voted unanimously to adopt Ordinance Number 15 on second reading.

Mr. Rhodes requested Council adopt a resolution stating that the van ambulances which are currently available on a General Services Administration contract are not in the opinion of Anderson County Council the most acceptable for use in Anderson County. On the motion of Mr. Rhodes, seconded by Mr. Bratcher, Council voted unanimously to adopt the resolution.

Mr. Herbert Marett discussed the Clemson University Extension Service's budget request for the 1977-78 fiscal year. Council accepted the Extension Service's budget request as information.

Mrs. Jean Taylor discussed Anderson County PATH, Inc's budget request for the 1977-78 fiscal year. Council accepted PATH's budget request as information.

Mr. Ernest Garrison discussed the Board of Tax Assessments and Appeals' budget request for the 1977-78 fiscal year. Council accepted the Board of Tax Assessments and Appeals' budget request as information.

Mr. Hooper requested Council adopt a resolution authorizing the Anderson County Planning and Development Board to serve as the representative of County Council on the Civic Center Committee to serve in an advisory capacity only and have no power or authority to bind the County Council. On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted three (3) to two (2) to read the resolution. Councilmen Joseph G. Wright, III, Sam S. Gerrard and David L. Hooper voted to read the resolution. Councilmen Fred Bratcher and Daniel A. Rhodes voted against the motion. On the motion of Mr. Gerrard, seconded by Mr. Rhodes, Council voted unanimously to refer the matter to the Planning and Development Board.

Mr. Carlisle Thompson discussed Broadway Lake Commission's budget request for the 1977-78 fiscal year. Council accepted Broadway Lake Commission's budget request as information.

Mr. Alridge Carver requested Council to assist the Wren Booster Club in the construction of a baseball field on land that was donated to the Booster Club. Mr. Poore suggested Mr. Carver contact Mr. Calvin Barnette of the Planning and Development Board.

On the motion of Mr. Wright, seconded by Mr. Rhodes, Council voted unanimously to adjourn at 7:50 p.m.
