Laura,

To follow up on our conversation yesterday, I want to reconfirm my understanding of the DOR expected Enforced Collections for the rest of this fiscal year.

DOR expects to collect an additional \$40 million in enforced collections before the end of the year from which the third and fourth quarter thresholds totaling \$22.5 million (\$11.25 million per quarter) must be subtracted which will leave a net amount of \$17,500,000, that will be available to fund the appropriations in Proviso 90.21 "Increased Enforcement Collections."

These estimates and my understanding of the math with the "thresholds" is critical as we will be short in the overall appropriations for Proviso 90,21.

Please reconfirm that this information on DOR's estimates is correct.

As to future expectations for collections, we anticipate approximately \$40 million before the end of the fiscal year.
