I Brenda Lee Prioleau Sumpter was the Proud Parent of two children a daughter Jakeera Monay Winston and a son Johnnie Roosevelt Winston 111; We lived in New Jersey until we moved to South Carolina in 1995 for Peace, Protection and Safety for myself and my children everything was going well until my daughter Jakeera became (17) seventeen years old and started to become a rebellious child at home and at school where the fear of the Lord God was no longer in her, my daughter Jakeera came out of High School Pregnant with a child my first grand-daughter Jataya who I raised until she was (3) three years old my daughter Jakeera refuse to go back to school or get a Job, she was told she had to do one or the other to help out in the home we lived, instead my daughter Jakeera decided to get Pregnant again with a second grand-daughter Janiya having me to raised two grand-daughters by myself with no help from my daughter Jakeera or the fathers of my grand-daughters, after talking to my daughter Jakeera about her life living and the road that she was traveling on I told her that she had to be a responsible parent for herself and the girls, my daughter Jakeera didn't understand what I meant by telling her about responsibilities, that she had to take on now, that's when she decided to move out of my home in 2007 when the second grand-daughter was only (4) four months old, and I was still providing for my (3) three girls, my daughter Jakeera had me

Audit by the (IRS) for (2) two years 2008-2009, that's when it all started to fall apart, my daughter Jakeera went from a bad relationship with Israel Anquin Collins who took my daughter from the home that she resided and Mr. Collins was using substance drugs for some time until he was sent to a rehabilitation center by his parents, Mr. Collins was very abusive to my daughter Jakeera and grand-daughter Jataya after pursuing her to live with him, my daughter Jakeera moved house to house from one of my sister Lilla Jenkins of Santee, SC to another sister Luneice Fuller of Jersey City, NJ until she came back to South Carolina from one bad relationship to another putting my grand-daughters in harm way, until my daughter Jakeera did the unthinkable one thing by marrying a Murderer who took the life of his own flesh and blood daughter a (4) four month old little girl name Ebony Smith, its public knowledge and news to everyone, I asked my daughter Jakeera what's wrong with her to put my grand-daughters into this mess with her my daughter Jakeera got married on May 17,2014 to Wesley Smith a Murderer she don't know nothing about, him or his background, and I address this situation long before my daughter Jakeera decided to married Mr. Smith, I asked begged pleaded with my daughter not to get married that she should wait for one year to buy her some time not to marry him, but my daughter wouldn't listen to me my mother preachers family members even friends of the family, my daughter Jakeera is not

herself and have not been for some time she almost lost her life on Dec.11,2013 at trident hospital and sign herself out of the hospital risking her life on Dec.13,2013 against the doctor orders because my daughter learn that Mr. Smith was home on Dec.12,2013 after my daughter along with two Pastors Elijah and Cheri McDaniel helped this Murderer get out of Prison, and (5) five days later Mr. Smith started Beating my grand-daughters between Dec.17 or Dec.18 2013 I have a recording that one of my grand called 911 on Dec.23,2013.The oldest one Jataya(9)nine years old got a beaten with her clothes removed from body on Mr. Smith lap while my daughter Jakeera watches, my grand-daughter told me she was scared of Mr. Smith, then I knew Wesley Smith took away her pride and dignity, and the youngest one Janiya (6)six years old gets Beatings behind closed doors my daughter Jakeera can't see her own child get a beating if any, I learn all of this on Dec.31,2013 New Years Eve from the oldest grand Jataya, I went to talk to my daughter Jakeera about this horrible act that took place that evening and again the next day January 1,2014 and received nothing but lips smart mouth from my daughter Jakeera and Wesley Smith about my grand-daughters, when I decided to get help once again from the Department of Social Service in Moncks Corner SC, I went to them in Dec.2007 when the second grand-child was born Janiya (4) four month old when my daughter moved out of the home with my (2) two

grand-daughters DSS didn't help me then and now I am back again years later January 2, 2014 with a more Serious case against my daughter Jakeera and DSS have been shifting me from case to case (4) four case workers in all and finally said that South Carolina dose not have Grand Parents Rights Law that needs to change Grand Parents are raising there grandchildren most of them because they don't want them to end up in foster care, I have a Concern about my grand-daughters living, my daughter Jakeera is running from City to City and she's about to run State to State because Mr. Smith was removed from the home in Berkeley County at the Fox Creek Apt. in St. Stephen, SC. by the Department of Social Services, I am afraid my daughter Jakeera and grand-daughters are being Brain Washed and Abusive by Mr. Smith my grand-daughters are asking to see me but my daughter Jakeera and Mr. Smith are refusing to let my grand see me, my oldest grand Jataya is acting out in class getting into trouble because she wants to see and live with me, we are close my grand and myself, I have not seen my grand-daughters since September 3, 2014. Please I need some assistance from the State, I thought it was children right that comes first and foremost that's what we should be focusing on children are our future, I miss my daughter Jakeera I am asking for help for her she needs to be evaluated now before it's too late, I miss my Grand-daughters,

Please look into this matter immediately because Wesley Smith  
has no right being around any Child less Children,
