Historical background : The US Roman Catholic Bishops organized National Right to Life in **1968**

National Right to Life was originally formally organized by the US Roman Catholic Bishops (then-**NCCB**) in **1968**.

National Right to Life Committee (NRLC) originally founded in 1968 under the auspices of the National Conference of [ Roman ] Catholic Bishops (NCCB)

"The Supreme Court decision of January 22, 1973, overthrowing all existing abortion laws, led to an enormous growth in the movement. The National Right to Life Committee which had been founded in 1968 under the auspices of the National Conference of Catholic Bishops, in 1973 became autonomous and non-sectarian. It is the largest and most influential national organization, with well over two thousand local affiliates by the 1980s."

Austin, Texas, Mar 1, 2018 / 07:00 pm ([CNA](#)).- The Texas Catholic Conference of Bishops has suggested churches in Texas sever ties with pro-life group Texas Right to Life, encouraging Catholic to volunteer with other pro-life groups in the state.

The TCCB's advisory was read after Masses and printed in church bulletins in the Diocese of Fort Worth last Sunday.

Texas Right to Life is the state affiliate of National Right to Life.

The TCCB urged in a [parish advisory notice](#) that Catholics not be involved with Texas Right to Life's activities and that parishes not allow the organization to use their sites for events.

The TCCB cited Texas Right to Life's opposition to incremental pro-life reforms, such as laws that restrict certain types of abortion rather than outlaw the act entirely, and mentioned "conflicts on end-of-life reform" and issues with the organization's voter guide among their concerns about the organization.

The TCCB claimed that Texas Right to Life's voter guide excluded pro-life members of the Texas legislature, and "was not based on a fair analysis of a legislator's work."

"Unfortunately, a number of legislators who have consistently voted for pro-life and end of life legislation have been opposed by Texas Right to Life," said the bishops.

The TCCB encouraged people to volunteer their time with other pro-life organizations as well as Church-sponsored pro-life ministries.

On its website, Texas Right to Life issued a [statement](#) defending themselves from the TCCB's claims, saying they were "disappointed but not surprised." Texas Right to Life stated that the bishops were being "uncharitable" in their description of the group, and that they had in fact worked hard to secure wins in the legislature.

Texas Right to Life has been officially and publicly rebuked and sanctioned by the Texas Roman Catholic Bishops (TCCB) for reasons including not falling in line

with the TCCB's even moreso perpetual incremental regulation of child-murder-by-"abortion",  
and for opposing RINO allies of the TCCB in the Texas State Legislature in TRTL's scorecard.

As gradualist turned abolitionist American **William Lloyd Garrison** asked rhetorically regarding the battle in America to end Slavery in the 1800's:

"... Has not the experience of two centuries shown that gradualism in theory is perpetuity in practice?"

Observations :

1) Even though Texas Right to Life is significantly incrementalist, having previously supported the detestable so-called "**pain capable**" legislation, and the repugnant "**dismemberment**" bill [ neither of which establishes justice as does **personhood** , which TRTL has **not** advocated ], **TRTL is still not incrementalist enough for Rome's Pope - appointed Bishops in Texas** , as TRTL did not support other incrementalist legislation supported by the TCCB.

2) TRTL also took to task RINO's in the Texas State Legislature who obstructed even TRTL's incrementalist bills, and opposed them in the TRTL scorecard. The Texas Roman Catholic Bishops took offense at RINO allies of the TCCB in the Texas State Legislature being scored negatively in TRTL's voter's guide. The Texas Republican Primary was scheduled for **March 6**.

To paraphrase William Lloyd Garrison and adapt his quote to the most important human rights battle currently in America:

"... Has not the experience of over four decades shown that incrementalism in theory is the perpetuation of child-murder-by-"abortion" in practice?"

The organization Texas Right to Life at times seeks volunteers from parishes and Catholic schools to participate in their efforts. We write to inform you of our concerns with Texas Right to Life and **we urge parishes not to participate in their activities or allow the organization to use parish sites.**

1. Conflicts on pro-life reform. Texas Right to Life often opposes the Texas Catholic Conference of Bishops and has implied that the bishops do not faithfully represent Church teaching. **Part of the dispute is rooted in Texas Right to Life's rejection of incremental pro-life reforms,** which bishops support following the guidance of St. [ CLL/CCL: sic ] John Paul II's **Evangelium Vitae**. An incremental reform is one which improves the current situation but does not reform the status quo as much as we might desire. It is "incrementally" better than the status quo.

**Evangelium Vitae** states:

A particular problem of conscience can arise in cases where a legislative vote would be decisive for the passage of a more restrictive law, aimed at limiting the number of authorized abortions, in place of a more permissive law already passed or ready to be voted on... This [vote] does not in fact represent an illicit cooperation with an unjust law, but rather a legitimate and proper attempt to limit its evil aspects. (EV, 73) [ CLL/CCL: sic ]

CLL/CCL Note: **Evangelium Vitae** [ V atican ] translated from Latin to English means: "Gospel of Life" [ sic ]. It was promulgated by former Pope John Paul II in 1995. So here we see Papal / Vatican endorsement for incremental child-murder regulation legislation, going back over 20 years. Christians, this is part of what we are fighting by advocating Biblically-based personhood legislation which seeks to establish justice for preborn human beings consistent with the Word of God ( e.g., the Sixth Commandment, Exodus 20:13, **KJV** ). **The Bible is NOT the supreme authority for Rome.** Rome is one of the

biggest obstacles to **ENDING**

( instead of perpetually, incrementally "regulating" ) child-murder-by-"abortion" in America.

Rome's so-called "Gospel of Life" [ sic ]

defends the incremental regulation of child-murder. **At the same time, Rome's Pope-appointed Bishops in Multiple States have opposed Personhood Legislation !!!**

In a surprising move last week, the Texas Catholic Conference of Bishops, the church's public policy voice in a state of more than eight million Catholics, directed all parishes to refrain from activities with Texas Right to Life, the state's oldest and largest pro-life organization.

"Texas Right to Life often opposes the Texas Catholic Conference of Bishops and has implied that the bishops do not faithfully represent Church teaching," the bishops wrote in a [parish advisory](#). They went on to highlight three main areas where Texas Right to Life has misrepresented Catholic positions or made misleading attacks on Texas legislators.

On pro-life issues, the bishops cited Texas Right to Life's [opposition to incremental reforms](#) to reduce abortions like H.B. 200, [a state ban on partial-birth abortion](#), arguing that such an approach is in keeping with the guidance of St. [ [CLL/CCL: sic](#) ] John Paul II's encyclical "Evangelium Vitae."

If a personhood law were to pass, its constitutionality would be challenged. The lawsuit would move up the courts and

would ultimately be heard by the Supreme Court, thereby directly challenging Roe v. Wade.

Having the right number

of Pro-Life Supreme Court justices is essential to overturning Roe v. Wade [ CLL/CCL: sic ].

Currently, we do not have

that number, and a decision by liberal judges would reaffirm Roe and prevent the Pro-Life position from being heard

in that court for another several decades [ CLL/CCL: sic ].

However, we can take a different approach by crafting legislation that will eventually yield the opportunity to successfully

overturn Roe v. Wade. This means defeating abortion through a strategy called incrementalism: ... [ CLL/CCL: sic ].
