BACKGROUND INFORMATION:

- S.1189 was signed on June 2, 2014

- Allows solar energy systems leasing by non-utilities in South Carolina, updates net metering policies, establishes a voluntary Distributed Energy Resource program for utilities and allows utilities to recover renewable energy costs by using the annual fuel rider.

- S.1189 is a balanced compromise bill developed by electric cooperative, investor-owned utilities, solar power proponents and conservationist to open the way for more distributed energy production in South Carolina.

- Other significant pieces of clean energy legislation signed this year H.3125 also known as the Clean Energy Industry Manufacturing Market Development Advisory Commission.
