In a matter of days last June, Gov. Nikki Haley, the legislature and the state's Department of Health and Environmental Control changed – at least temporarily – rules covering new health care construction and equipment in South Carolina. Haley vetoed almost \$2 million in funding for the state's certificate of need program for health care projects.
