Good afternoon Lily. We haven't met but my name is Elizabeth Ford and I manage the Family Caregiver Program and the Alzheimer's Resource Coordination Center. I have been talking with staff here as well as Debbie and Darryl. I also have had a few conversations with Macie Smith about the Urban League Events. I know a lot of people have had various conversations about the event so I was trying to reign it in a bit. I didn't want there to be any confusion about who was attending, when and what was needed. When I spoke with Darryl, he mentioned that he will attend the first night and will hopefully be able to have the Lt. Governor attend with him. I know that General Assembly is finishing up that week. Obviously, anything can happen in session and that is the Lt. Governor's first priority. However, besides any unforeseen circumstances, do you think it will work scheduling wise for the Lt. Governor to attend on May 9<sup>th</sup> in Columbia? We will have staff members on the panel so that is taken care of. If he is able, it would be good if he could talk about 5-10 mins on elder abuse and the importance of community involvement and education. I will gather some talking points for him. I was hoping to go that first night but will be out of the country. In fact, after next week, I will be out for 2 week. If you it would be better to talk via phone – I am more than happy to answer any questions or concerns!
