

GOVERNOR HALEY,

I HAVE WRITTEN YOU 3 LONG LETTERS CONCERNING HOW MY GRAND DAUGHTER'S LIFE WAS AND STILL IS BEING DESTROYED. I WROTE THE FIRST ONE IN MARCH OF 2014. I SENT THEM BY REGISTERED MAIL TO YOU PERSONALLY BECAUSE YOU ARE NOT ONLY THE MOST POWERFUL PERSON IN THE STATE OF SOUTH CAROLINA BUT ALSO A MOTHER I WANTED YOU TO READ THESE LETTERS PERSONALLY. I DON'T SEE HOW ANY MOTHER, WHO HAS THE POWER TO DO SO, WOULD ~~NOT~~ HELP THIS YOUNG GIRL OR ANY YOUNG PERSON OUT OF THE SITUATION SHE HAS BEEN IN FOR THE LAST 3 YEARS. I EXPLAINED EVERYTHING THAT HAS BEEN GOING IN THE PREVIOUS ~~3~~ 3 LONG LETTERS I WROTE TO YOU. THEY SHOULD BE ON FILE THERE UNLESS SOMEONE THREW THEM AWAY. I HAVE COPIES.

THESE LETTERS DETAILED HOW SOMER'S FATHER, JEFFREY KARLSONS, TOOK SOMER FROM HER MOTHER'S CARE WHEN SHE HAD JUST TURNED 13 YEARS OLD. HE HAS PRIMARY CUSTODY AND DID THIS SO HE WOULDN'T HAVE TO HELP SUPPORT SOMER. WHEN SOMER WAS IN HER MOTHER'S CARE SHE WAS A SWEET, INNOCENT, GOD LOVING YOUNG GIRL.

WHEN SOMER'S FATHER TOOK HER INTO HIS CUSTODY HER LIFE IMMEDIATELY WENT INTO A DOWNWARD SPIRAL. IT'S TRAGIC AND ALMOST UNBELIEVEABLE THE BAD THINGS THAT HAS HAPPENED TO SOMER BE CAUSE OF HER FATHER'S NEGLECT OF HER AND LACK OF CONCERN ABOUT WHAT WAS HAPPENING TO HER. HE FRANKLY DOESN'T CARE WHAT HAS HAPPENED AND IS STILL HAPPENING TO SOMER. THAT IS UNLESS IT GETS HIM IN TROUBLE WITH AUTHORITIES OR COSTS HIM MONEY.

HE TOOK SOMER TO YORK, SC. WHERE HE TURNED HER LOOSE TO GO WHERE EVER SHE WANTED TO GO, DO WHATEVER SHE WANTED TO DO, ASSOCIATE WITH SOME VERY BAD PEOPLE AND THUGS AND STAY AS LONG AS SHE WANTED TO.

DURING THIS TIME POLICE HAVE STOPPED CARS AT 2 OR 3 OCLOCK IN THE MIDDLE OF THE NIGHT AND FOUND SOMER INSIDE WITH SEVERAL MEN. THE ALSO PICKED HER UP IN YORK ONE NIGHT ABOUT 3AM WALKING WITH SEVERAL MEN.

IT HAS ALSO BEEN DOCUMENTED THAT SHE HAS HAD SEX WITH AS MANY AS 20 MEN.

THIS ALL HAPPENED WHEN SHE WAS 13, 14, 15 YEARS OLD. THAT IS STATUATORY RAPE BUT NO ONE HAS EVER BEEN CHARGED.

ALL OF THIS HAPPENED WHILE SOMER WAS IN HER FATHER'S CARE OR LACK OF CARE.

DURING THIS TIME D.J.J. HAS HAD HER PUT INTO CUSTODY AT SEVERAL PLACES FOR SEVERAL MONTHS.

— NOW TO THE PRESENT —

ON JUNE 17TH, 2015 SEVERAL NOTEABLE EVENTS HAPPENED. SOME GOOD - SOME BAD

① NINE PEOPLE WERE SHOT AND KILLED IN A CHURCH IN CHARLESTON. THIS WAS TRAGIC.

② SOMER WAS BROUGHT TO ROCK HILL BY D.J.J. FROM SUMMERVILLE WHERE SHE HAD BEEN HELD IN CUSTODY FOR NINE MONTHS TO APPEAR AT A TEMPORARY CUSTODY HEARING.

THE BAD THING ABOUT THIS IS: THE JUDGE WHO KNEW VERY LITTLE ABOUT THE CASE AND HAD NEVER BEEN ON THE CASE BEFORE LET JEFF KARLSON SPEAK AT LENGTH, A SPEECH FILLED WITH LIES AND FALSE PROMISES.

HE MADE HIMSELF SOUND LIKE A MODEL PARENT AND PROMISED TO CLOSELY SUPERVISE SOMER AND HE WOULD NOT LET HER GO TO PLACES WHERE SHE COULD GET INTO TROUBLE.

WHEN HE FINISHED HIS SPEECH I ~~ASKED~~ ASKED THE JUDGE IF I COULD SPEAK AND SHE SAID NO. I WANTED TO DISPUTE SOME OF

THE THINGS HE HAD SAID BECAUSE I KNEW A LOT OF THE THINGS HE HAD TOLD THE JUDGE WERE NOT TRUE. HER MOTHER ALSO DID NOT GET TO SPEAK IN COURT.

THE JUDGE WENT INTO HER CHAMBERS. IN A FEW MINUTES SHE RETURNED AND AWARDED TEMPORARY CUSTODY TO JEFFORY KARLSON, SOMER'S FATHER. THIS IS THE WORST THING THAT COULD HAVE HAPPENED.

THIS IS NOVEMBER 10TH, 2015, THAT HEARING WAS ALMOST FIVE MONTHS AGO (6-11-15).

HERE IS WHAT HAS HAPPENED TO SOMER IN THE LAST FIVE MONTHS — ALL BAD!

BACK IN JUNE AS SOON AS HE LEFT THE COURTROOM JEFFERY KARLSONS TOOK SOMER TO YORK, SC. AND IMMEDIATELY STARTED DROPPING ^{HER} OFF WITH THE SAME PEOPLE THAT HAD GOT HER INTO TROUBLE BEFORE. THIS IS ONE OF THE THINGS HE SAID HE WAS NOT GOING TO DO. HE TOTALLY TURNED HE LOOSE WITH NO SUPERVISION AND AGAIN SHE GOT RIGHT BACK INTO DRUGS, SEX AND HANGING OUT WITH THUGS IN YORK. SHE ALSO HAS HAD ANOTHER CASE OF V.D.

NOT TOO LONG AFTER THE JUNE COURT HEARING THE ROCK HILL POLICE STOPPED A CAR IN THE MIDDLE OF THE NIGHT.

INSIDE THEY FOUND SOMER AND SEVERAL MEN A FEW WEEKS LATER THE YORK POLICE FOUND THE SAME WHEN STOPPING A CAR.

ABOUT A MONTH AGO SOMER GOT TATTOED ON HER ARM WHILE OUT ON HER OWN.

- LAST - THE WORST -

ON FRIDAY AFTERNOON 10-30-15 THE DAY BEFORE HALLOWEEN I WAS VISITING SOMER'S MOTHER, TERESA KARLSON HUGHES.

THE PHONE RANG AND IT WAS SOMER ASKING HER MOTHER IF SHE WOULD SAY IT WOULD BE O.K. ~~FOR A CERTAIN GIRL IN YORK~~ FOR HER TO SPEND THE NIGHT WITH A CERTAIN GIRL IN YORK, THIS WAS THE GIRL THAT HAD BEEN GETTING SOMER IN TROUBLE. HER MOTHER TOLD HER NO AND EXPLAINED WHY. SOMER DIDN'T LIKE THAT AND HUNG UP. THE PHONE RANG AGAIN. THIS TIME IT WAS JEFFERY KARLSON.

WHEN MY DAUGHTER ANSWERED HE ASKED HER TO O.K. SOMER'S VISIT WITH THIS GIRL.

SHE TOLD HIM NO BECAUSE THAT WAS ONE OF THE PLACES WHERE SOMER HAD BEEN GETTING IN TROUBLE AND DOING BAD THINGS.

JEFFERY KARLSONS HUNG UP.

MY DAUGHTER DIDN'T HEAR ANY MORE FROM OR ABOUT SOMER UNTIL MONDAY 11-2-15,

WHEN SHE GOT THE PHONE CALL ON MONDAY (11-2-15) SHE FOUND OUT THAT JEFFREY KARLSONS HAD LET SOMER GOT STAY WITH THE GIRL MENTIONED BEFORE, AGAINST HER MOTHERS WILL.

WHILE AT THIS GIRL'S HOUSE SOME THUG GOT SOMER INTO HIS CAR AND TOOK HER SOMEWHERE IN INDIAN LAND, S.C.

THERE SHE WAS DRUGGED, PASSED OUT AND RAPED. WHEN SHE WOKE UP HER PANTS WERE ON BACKWARDS.

AS SHE WAS BEING DRIVEN BACK TO YORK SHE GOT SICK AND VOMITED IN THE THUG'S CAR WHO CUSSED HER OUT FOR MESSING UP HIS CAR.

I DON'T KNOW ALL THE DETAILS NEXT BUT THIS GENERALLY WHAT HAPPENED NEXT:

WHEN SHE GOT BACK TO YORK SHE STARTED CUTTING HER LEG.

SHE SWALLOWED A LARGE AMOUNT OF PILLS (SUICIDE ATTEMPT?). SHE WAS THEN TAKEN FOR MEDICAL TREATMENT WHERE SHE WAS MADE ^{TO SWALLOW} SOME SOLUTION TO COUNTER ACT THE PILLS. SHE WAS ADMITTED TO THE HOSPITAL HERE IN ROCK HILL AND THEN TAKEN TO FACILITY NEAR LANCASTER FOR A MENTAL CHECK UP.

SOMER'S MOTHER HAS BEEN TOLD THAT SOMER WILL BE DISCHARGED FROM THAT FACILITY IN A VERY SHORT WHILE. THEN WHAT HAPPENS TO HER? THIS IS LITERALLY KILLING MY DAUGHTER. SHE HAS WANTED PRIMARY CUSTODY OF SOMER EVER SINCE THEIR ^{DIVORCE} BUT HE BLOCKED IT FOR TWO REASONS: MONEY AND TO SPITE HIS EX-WIFE. NOW THAT SHE HAS BECOME UNMANAGEABLE AND CAUSING HIM PROBLEMS HE IS READY TO KICK HER OUT, EVEN ON THE STREET IF NECESSARY. HE NEVER REALLY WANTED HER TO LIVE ^{WITH} HIM.

JEFF KARLSONS ONLY LOOKS OUT FOR ONE PERSON --- JEFF KARLSONS.

I AM INCLOSING A TEXT MESSAGE SENT TO MY DAUGHTER'S PHONE IN WHICH HE SAYS SOMER CAN NOT COME BACK TO HIS HOUSE. HE AND THE LOCAL DSS HAS DESTROYED TWO LIVES: SOMER'S AND HER MOTHER'S.

I AM AN 83 YEAR OLD VETERAN. IF YOU WANT TO THANK ME FOR MY SERVICE READ THIS LETTER AND THE 3 OTHERS AND TAKE ACTION TO SAVE MY GRAND DAUGHTER'S LIFE. I HOPE IT'S NOT TOO LATE.
