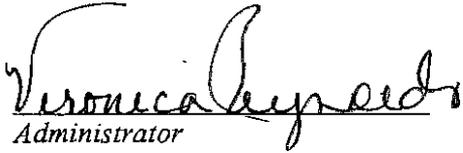
Topics of discussion
