The Court's attached Order of 11.5.15 required, within one week of the end of the legislative session, a report of the Defendants on efforts to implement a "constitutionally compliant education system, including all proposed, pending or enacted legislation." In response to a request from Bobby Stepp, the Court has said that the report may be submitted by June 29, 2016. Although legislation is the key component, the State and the Governor are also parties, as you know.

Bobby advises that the substantive information that the House and Senate will present will come from the House and the Senate to be attached to a "proforma 'report'" that simply refers to their attachments. He will share it with me when he receives it.

Would the Governor Office like to do some type of concurrence in the House and Senate report, or does your Office prefer to do a separate report?

I will be at the beach the week of the 27<sup>th</sup> with my family, but I should be able to handle this matter remotely if not in advance.

Please let me know what your Office would like to do.
