Governor Nikki Haley News:

Associated Press: Haley scheduled to announce latest Cabinet pick

South Carolina Gov. Nikki Haley is slated to announce a Cabinet appointment. The governor plans to reveal her latest agency appointment at a news conference at 10:30 a.m. Thursday. A news release from Haley's office didn't say which agency she was going to discuss, but Department of Corrections Chief Bill Byars announced last month that he was going to retire at the end of September. Byars led South Carolina prisons for three years and served as the leader of the state Department of Juvenile Justice before that.

Aiken Standard: Local farmers can apply for emergency loan due to damaged crops

Aiken County farmers have approximately eight months to apply for an emergency loan program if more than 30 percent of their crops have been damaged due to excessive rain and flooding. The U.S. Department of Agriculture approved Haley's request so farmers can become eligible for low-interest emergency loans through the next eight months.

Note: Gov. Nikki Haley requested a disaster declaration on Aug. 19 for the entire state due to crop damage by flooding and rain. Haley requested 36 counties, including Aiken, be designated as Primary Disaster Counties, and the remaining 10 be labeled Contiguous Disaster Counties. Those include Abbeville, Anderson, Chester, Fairfield, Greenwood, Kershaw, Lancaster, Lexington, McCormick and Oconee.

Associated Press: Haley to start mileage reimbursement

Gov. Nikki Haley should have been reimbursing taxpayers for mileage in state vehicles to her fundraising events ever since she took office, the director of South Carolina's ethics agency told The Associated Press on Wednesday. The governor's attorney disagrees with that opinion and plans to seek another one from commissioners who oversees the agency. Meanwhile, any reimbursement has been put on hold.

Note: Haley's campaign began logging mileage to her fundraising events Sept. 26 when she publicly declared her re-election bid, campaign spokesman Rob Godfrey said. He added that the campaign will begin making those payments as part of quarterly reimbursements. The Republican governor has previously reimbursed only for additional costs her security detail incurred for fundraisers during out-of-state trips, such as agents' additional hotel nights and meals.

Note: Godfrey said the campaign's decision on the timing followed "decades-old precedent" that a governor's formal announcement triggers mileage reimbursement, based on discussions with officials at the State Law Enforcement Division, which provides the governor's security as per state law.

You could hear Lykes' name again, during the 2014 governor's race, as Gov. Nikki Haley pushes back against criticism of her handling of the Revenue Department hacking.

Note: "This says a lot about who Vince Sheheen is – someone who (is) quick to chase crises and point fingers, someone who recommends a thief for a state job because the applicant's a well-connected Democrat, and someone who walks away from accepting any responsibility himself," Haley campaign spokesman Rob Godfrey said. "It's a shame but unsurprising."

Tuesday it is establishing its new production facility in Richland County. The \$500,000 investment is expected to generate 100 new jobs over the next three years. Two days after Labor Day: The Crown Group, a provider of coating services to the automotive, heavy truck and agriculture industries, on Wednesday announced that it has opened a new plant in Greenville County. The \$5.4 million investment is expected to generate 42 new jobs over the next five years.

Note: According to SCDC, since January 2011, the month Gov. Nikki Haley took office; South Carolina has recruited more than \$9 billion in capital investment and more than 26,000 jobs in the manufacturing sector. In the automotive-related sector alone, the totals are \$5.1 billion in investment and more than 8,500 jobs.

Many of President Barack Obama's opponents expressed relief last week when he said he will seek approval from Congress before launching a military strike against Syria in response to that country's use of chemical weapons against anti-government rebels. But the delay and the open disagreement spurred by such a debate could serve to render completely ineffective an already dubious course of action. The apparent actions by the Syrian government of Bashar al-Assad are deplorable. It is increasingly evident that the government used Sarin gas in an Aug. 21 attack that killed 1,429 people, including 426 children. As the Obama administration has made clear, the Syrian government's actions are reprehensible and deserve a harsh response from the international community.

Syrian Bashar al-Assad must be grateful that President Barack Obama has taken so long to mobilize a strike against Syria. It buys Assad time to relocate potential targets and deploy troops out of the likely line of fire. Nonetheless, Americans also should be grateful for this careful slow walk toward such a monumental decision. We are better off sacrificing part of the element of surprise than rushing into an attack without laying the groundwork first. Even Obama's inner circle allegedly was surprised by his decision last week to seek the approval of Congress before launching an attack. Although he already is persuaded by the evidence that Assad is guilty of using poison gas to kill more than 1,400 Syrians, including hundreds of children, and that the regime should be held accountable, he also is convinced that the support of Congress would bolster his case.

Oklahoma Gov. Mary Fallin signed an extradition order Wednesday to send the father of a Cherokee girl in the middle of a custody dispute to South Carolina to face a criminal charge for refusing to hand his 3-year-old daughter over to her adoptive parents. But a lawyer for Dusten Brown says he doesn't believe his client will be extradited, insisting Brown has not committed a crime and that a judge will not enforce the order. Brown was charged last month with custodial interference, and a warrant for his arrest was issued out of South Carolina. Brown and Matt and Melanie Capobiano, of James Island, S.C., have been fighting for years over Veronica. The Capobianos were finalized as her adoptive parents in July, but Brown did not turn over the 3-year-old girl.

Instead of eagerly preparing for his daughter's fourth birthday celebration, Dusten Brown grew worried Wednesday that he would be arrested and miss the milestone. Oklahoma's governor signed an extradition warrant that cleared the way for authorities there to arrest Brown and send him to Charleston, where he faces a felony charge of custodial interference for refusing to give up Veronica. The toddler, who was adopted by a James Island couple she lived with for 27 months, turns 4 on Sept. 15. Lori Alvino McGill, the Washington attorney for Veronica's birth mother who has spoken in favor of the adoptive parents, praised the governor's "decisive action" to help end the case.

South Carolina's senior U.S. senator spoke Wednesday after an appearance before the military affairs committee of the Greater Sumter Chamber of Commerce. He stressed the need to maintain military readiness in an age when Graham admits many Americans are weary after a decade of war. The Savannah River Site has confirmed its efforts to maintain radionuclide leaks caused by cracking in a vault on Site. Vault 4 was previously used for the disposal of nuclear waste from high-level waste tanks. As of now, the vault is no longer being used to receive radioactive salt waste. Information on the leakage was uncovered after Tom Clements, a member of Friends of the Earth, filed a Freedom of Information Act request on Aug. 6. The Department of Energy's Savannah River Site identified the leakage in February. Department officials stated the problem stems from cracks in the roof of the vault. On July 31, SRS submitted a letter to the S.C. Department of Health and Environmental Control outlining the issue and the Site's repair efforts.

lawsuit, filed Wednesday afternoon, lists Florence County, Florence County Council and the Florence County Registration and Elections Commission. It asks for an injunction against a referendum vote. Council pushed forward with extending the tax, first approved by voters in 2006, by setting up community meetings earlier this year to solicit feedback and formulating a referendum question with a list of proposed projects that would be paid for by the seven-year tax, also known as the penny tax.

A massive drive to collect signatures to force a referendum on a strong-mayor form of government in Columbia won't get the 11,000-plus signatures needed to put the issue on the Nov. 5 ballot. Any special election to let voters decide the strong mayor question now almost certainly will be held after Jan. 1. Petition drive organizers said Wednesday that about 5,000 or so verified registered city voters have signed the petition calling for a referendum. Under state law, they have to have signatures of 11,500-plus city residents, or 15 percent of the city's 75,000 or so registered voters.

The No. 1 question about President Barack Obama's health care law is whether consumers will be able to afford the coverage. Now the answer is coming in. The biggest study yet of premiums posted by states finds that the sticker price for a 21-year-old buying a mid-range policy will average about \$270 a month. That's before government tax credits that act like a discount for most people, bringing down the cost based on their income. List-price premiums for a 40-year-old buying a mid-range plan will average close to \$330, the study by Avalere Health found. For a 60-year-old, they were nearly double that at \$615 a month.
