Hey Catherine-

I have attached Mr. Horne's reinstatement requirements. He is forever barred four times as a result of receiving four DUI'S within a ten year period. If he remains Alcohol/Drug/Driving under Suspension violation free from that date of his last DUI ( which is 2013, so he can petition in 2020) he can petition the Circuit court in the county that he lives in, under SC Code 56-1-385 to have his driving privileges reinstated. If granted, he will still be required to serve his suspension term through 02-04-2023, pending that he does not receive any more suspensions that will require him to serve additional suspension terms.

He owes \$3700 in reinstatement fees. He mentioned that he wanted to pay the reinstatement fees at a cheaper rate, but he must pay them at the rate they are when payment is being made. See SC Code 56-1-390 for more information on that.

He also has one outstanding ticket in the Anderson Summary Court-Ticket number D680713. This ticket must also be paid and compliance taken to DMV prior to reinstatement as well. He will also be required to file SR-22 insurance and have the Ignition Interlock Device (IID) installed (He will need to contact Department of Probation, Parole and Pardon for information in reference to IID) as well as successfully passing vision, knowledge, and skills test prior to getting his DL back.

I know this is a lot, please let me know if you need clarification on anything or if you need anything else!
