the 2nd time. He claimed Christinas children
& her on his income TAX and Christina does
not live in the home and hasn't for years. Her
mother doesn't want her there. And the
Childrens father just passed away 2-14-15
he was disabled and the Childrens father was
sending Social Security to his children and
Christinas paying child support. On Jan-16
2015 I just paid myself 600.00 to get her
out of jail to go on her back child support.
And did not tell Brenda Williams I was
doing it. Her Brothers name is John P. Williams
also. Her Fathers name is John P. Williams
Jr. Christinas brother filled income TAX
claiming 3 children & his sister lord knows
who else. Her mother called wanted her to
send her SC I'd to her to get her son out
of trouble. But Christina said no I'm
not getting into no trouble with IRS.
She gets on Face Book putting her daughter
Christina down. Only lets her see her

- Children when she's in the mood. And has a so called B-day party. Only cake no other children just 3 of her Grand Children. Every time Christmas sees her children there in old clothes torn shoes. Not sure she's spending the money on the children for things they need. And she is mean to them. Will not allow them to play with there new toys. Christmas took them toys from us for Xmas they haven't gotten to play with yet. And she took B-day gifts to them and she made them put them back in the gift bag. And made some remarks about the gifts they got for there birthday. She wants Christmas to sign there lights to her children away tonight. And last night Christmas told her NO over her dead cold body. She loves her kids and wants them here in GA with her. Her mother said she'll never get them back. There is a lot more to this case than the courts know about. Liz Goodland sent paper work to Christmas Job which she just started only makes 2.92 per hour no tips she is training. She only made 80.00 last wk. She ad the 20.00 for gas sent 10.00 for child support and got some personal things she needed it's gone. Some one filled out her court papers for her for a reduction in child support wrong. They put her fathers income down for hers. When she came to GA and found a job. Because she was baby sitting for a friend while in DC and she paid Christmas child support for her.

Christina couldn't go look for a job while living there. Cause she was always babysitting for her friend. Gov. Haley would you please help Christina. Christina only wants to be with her kids but feels everyone is against her. Her family only cares when they want something. Her mother will not allow her to call her own children and talk to them. And we are to afraid to take her to see her children afraid she'll have a warrant waiting on her cause of her greedy mother. Gov. Please help her. She is trying to get stable so she can get her children back with her. And everytime her mother drags her down money or jail. She threw it in her face on Face Book & Texting tonight better pay or you'll go to jail.
