- A detailed summary of economic benefits derived from the trip, including but not limited to expected contracts or business for the state and the expected number of new private or public sector jobs. This could include but is not limited to memos, emails or other documents written upon returning.

- A detailed summary of upcoming economic development trips for state officials.

On July 10, 2012, our office received your Freedom of Information Act request for records related to Governor Haley's economic development trip to the Farnborough Air show, including itineraries, expenses, emails, and attendees. Your specific information requests and our responses to them are provided below.

(1) *A detailed itinerary for Gov. Nikki Haley's trip to London.* We have provided the detailed itinerary from the Department of Commerce and the Governor's Office. Please be advised that information in the itinerary is redacted pursuant to the S.C. Freedom of Information Act where it constitutes (a) information of a personal nature where the public disclosure thereof would constitute unreasonable invasion of personal privacy (Section 30-4-4(a)(2)) or (b) memoranda, correspondence, and working papers relative to efforts or activities of a public body to attract business or industry to invest within South Carolina (Section 30-4-40(a)(9)).

(2) *All expenses – including but not limited to travel, food, hotels and entertainment – incurred during the trip. This should include names of restaurants and hotels. It also should include specifics regarding airfare and air/ground transportation in Europe. Please provide travel invoices, receipts, expense reports and/or reimbursement reports.* Some of this information is provided in the summary document prepared by the Department of Commerce as well as communications referenced in item (4). As detailed cost information becomes available, including invoices, receipts and expense reports from the Department of Commerce, they will be provided to you.

(3) *The total cost of the trip.* An estimated total cost of the trip is provided in the summary document prepared by the Department of Commerce; however the final cost will be determined when all invoices and receipts are received by the department.

(4) *Please provide any records – including but not limited to, memos, emails, or text messages – concerning the trip. This should include the costs and details of state sponsored events such as receptions or lunches.* Any emails and memos in the possession of the Governor's Office have been

provided that relate to costs of the trip and state sponsored events. Also, the summary document prepared by the Department of Commerce, which includes a description of costs, is also provided. We will provide additional detailed cost information as it becomes available.

(5) *Please provide a detailed description of how the trip was paid for.* This information is provided in the summary document prepared by the Department of Commerce.

(6) *A detailed list of people who accompanied Gov. Haley on the trip and all their expenses. If anyone helped cover costs, please specify.* Some of this information is provided in the summary document prepared by the Department of Commerce as well as communications referenced in item (4). As detailed cost information becomes available from the Department of Commerce, including a breakdown of expenses and who helped cover the costs of the state-sponsored portion of the trip, we will provide them to you.

(7) *A detailed list of any gifts that were registered with the state.* A document detailing two gifts that Gov. Haley received is provided. Please be advised that information in this document is redacted pursuant to Section 30-4-40(a)(9) (memoranda, correspondence, and working papers relative to efforts or activities of a public body to attract business or industry to invest within South Carolina).


(8) *Documents reflecting what Gov. Haley and the Department of Commerce expected to gain from the trip. This should include but is not limited to memos, emails or other correspondence written before the trip by the governor, top aides, economic advisors and officials in the Department of Commerce.* This information is provided in the summary document prepared by the Department of Commerce as well as in certain email communications prepared for media purposes that are included. Other public records that are responsive to this request, if any, are exempt from disclosure pursuant to S.C. On July 17, 2012, our office received your Freedom of Information Act request for:

[A]ll emails sent by Gov. Nikki Haley, her chiefs of staff and legislative staff since Jan. 1...[to] include those from state and personal accounts[;] ...a record of phone calls by the governor on her state cell phone during that same period[; and]text messages or Blackberry messages sent by the governor during that time..."

We have located records responsive to your request for Governor Haley and each of the staff members you identified for the time period beginning January 1, 2012 up to the date our office received the request. Due to the high volume of Freedom of Information Act requests received by the Governor's Office and the significant costs associated with producing the requests, our office will charge a reasonable cost of compiling and copying records as allowed pursuant to Section 30-4-30(b).

At this time, we estimate the total number of outgoing emails will be at a minimum 4,000; however this initial estimate does not include the pages associated with each email or attachments. We estimate the pages of attachments to be approximately 7,000. We estimate the pages of monthly phone records for the Governor's state cell phone to be six pages. Finally, we estimate the amount of staff time needed to compile these records to be four hours.

Our initial estimate of total cost for production of this records request is broken down as follows: individual emails total \$400.00 (4,000 pages at 10 cents per page); emails with attachments total \$1,100 (11,000 pages at 10 cents per page); phone records total \$0.60 (six pages at 10 cents per page); and staff time totals \$61.24 (four hours at an average hourly rate of \$15.38 per hour).



FOIA Request for Public Records Related to the Office of Governor Haley and the Nation's Highly Radioactive Spent Fuel Being Brought to South Carolina for "Consolidated" Storage

Dear Governor Haley:

I am hereby filing this request under the South Carolina Freedom of Information Act as stipulated in Title 30, Chapter 4. Per provisions in the law, I expect a response to this request within 15 days.

I am filing this request as the Nonproliferation Policy Director for the Alliance for Nuclear Accountability (ANA). ANA is a registered non-profit public interest organization with offices in Washington, DC, Santa Fe, NM and Columbia, SC. ANA has 35 members groups around the U.S., with a focus on clean-up and nuclear programs at U.S. Department of Energy sites such as the Savannah River Site (SRS) in South Carolina. ANA actively engages members of Congress, the public and the media related to the DOE budget and funding of clean-up and other activities. ANA likewise engages with the South Carolina Department of Health and Environmental Control (DHEC) concerning SRS issues.

In South Carolina, ANA serves the public interest as the primary private monitoring organization over activities conducted by DOE and contractors at the Savannah River Site. ANA regularly attends SRS meetings and is frequently quoted in the media concerning activities at SRS.

As the information sought will be used solely for non-profit public education and media purposes, I request that a waiver of all fees be provided to me. The information obtained will benefit the general public, given the demonstrated interest by the public and media in the issues addressed by this request. The information obtained will serve to inform the public about the workings of the governor's office in relation to the issue for which this request is being filed. ANA has a demonstrated ability to publicly and without cost disseminate information such as that which may be obtained from this request, including via our web site, via news releases and via briefings to Congress.

If any records are withheld, I request a full explanation and justification under the South Carolina Freedom of Information Act. I retain the right to appeal any denial of any aspect of this request and retain the right to pursue legal action to obtain the requested public records.



The public records indicated in this request are being sought in either hard or electronic copy.

I hereby request the following "public records" as it pertains to Governor Haley and gubernatorial staff:

All public records, including reports, documents, orders, emails, and phone records written by Governor Haley and staff, or in their possession, related to internal communication, including with other agencies of the Government of the State of South Carolina, or communication with the U.S. Department of Energy, including the Savannah River Site, concerning the receipt and storage of highly radioactive commercial spent fuel at the Savannah River Site for "consolidated storage."

This request applies to all emails and written communication by Governor Haley or her staff or agencies under her control.


This request applies to all communication with the DOE's Office of Nuclear Energy, including with Dr. Peter Lyons, Assistant Secretary for Nuclear Energy.

I request that the information be made available to me as it is located and not when the documents have all been accumulated.



Hot waste at SRS opposed

Environmentalists spoke out Thursday against sending waste to the Savannah River site.

Utilities, which relied on ratepayers' money, now want to be reimbursed.

At Thursday's Governor's Nuclear Advisory Council meeting in Columbia, representatives of four conservation groups said South Carolina should resist any federal plan to use SRS for disposal, even if the plan is considered interim.

"For too long, South Carolina has shouldered a disproportionate share of our country's nuclear waste," said Debbie Parker, a representative of the Conservation Voters of South Carolina. "We cannot endorse any negotiations that imply consent... for SRS to serve as an interim site for consolidation of commercial nuclear waste storage or for reprocessing."

Representatives from the state Sierra Club, the S.C. Coastal Conservation League and the Alliance for Nuclear Accountability also spoke out.

The alliance's Tom Clements said behind-the-scenes discussions now are occurring

among state leaders to allow the disposal in exchange for some type of jobs initiative. He did not name anyone, but said "it's time for those in on these discussions to reveal what they are up to" and tell the public.

Gov. Nikki Haley's spokesman said the final resting place for spent fuel should be Yucca Mountain. Republicans have been trying to reverse Obama's decision and open Yucca Mountain. The president canceled the Yucca Mountain project after years of complaints from Sen. Harry Reid, a Nevada Democrat, who said dumping waste in his state would hurt the environment.

Haley is "dedicated to keeping South Carolina from becoming a permanent home for this nation's unprocessed nuclear waste," spokesman Rob Godfrey said in an email to The State newspaper. "The solution to the waste problem we face is a mountain in Nevada. The experts at the Savannah River site can process and stabilize this waste, but its final home should be Yucca Mountain."



SRS is not suitable for high-level radioactive waste

No more nuclear waste

A coalition of environmental groups is correct in asking the state to resist any federal effort to send spent fuel from nuclear reactors to the Savannah River Site.

The federal government has no idea about what to do with high-level nuclear waste. It used to have a plan. In fact, it spent about \$10 billion of your money on that plan and then abandoned it. Now, it has no plan.

And when officials in Washington run out of ideas for where to put dangerous nuclear material, they usually fall back to the idea of storing it "temporarily" at the Savannah River Site. Much of the nation's plutonium from decommissioned nuclear weapons is stored at the site.

The fact that the site is located in a sensitive environment and near major population centers did not deter Washington. The fact that the facilities were not designed for long-term storage of this waste did not deter federal officials. They sent the dangerous material there, anyway.

They insisted it wouldn't stay long. They had two plans for permanent disposal of the waste. One of those plans was abandoned. The other is years behind schedule. Meanwhile, the waste sits there, posing an environmental hazard and a threat to the health of the people of this state.

And now, the federal government may want to ship spent fuel from nuclear power plants to the Savannah River Site. The state must object and do so strongly.

The truth is that there is no reason to send this waste to South Carolina. The nation has a perfect site for the disposal of this waste. It is ideally located, designed and built for the purpose. U.S. taxpayers have spent billions on its construction. It is the Yucca Mountain facility in Nevada.

But Senate Majority Leader Harry Reid doesn't want the site used. He'd rather the waste stay stored along the Savannah River. And President Barack Obama is his political ally, so Obama canceled plans to use the site.

The bottom line is that instead of using a site that is located, designed and built specifically for the purpose of storing this material, Washington may instead send it to the Savannah River Site, which is neither located, designed nor built for that purpose.

This is stupidity on a scale that only the federal government can achieve.

Gov. Nikki Haley and lawmakers must work with the state's congressional delegation to make sure that more dangerous nuclear material isn't sent to South Carolina. U.S. Rep James Clyburn should show that he is as important to the president as Reid. They must protect this state from Washington's willingness to sacrifice the health and safety of South Carolinians for petty political concerns.

Don't bring high-level nuclear waste to SRS in South Carolina

Published: September 15, 2012

S.C. must insist that high-level nuclear waste not be stored at SRS near Aiken.

If highly radioactive waste from the nation's nuclear power plants is sent to South Carolina, the probability is high that it will stay here, perhaps forever. That's why the state's residents and lawmakers need to insist that the federal government find somewhere else to store the waste.

Recently, a coalition of state environmental groups spoke out against a proposal to send spent fuel from the nation's 104 nuclear power plants to the Savannah River Site near Aiken. While the plan calls for using SRS as an "interim" storage site, past experience has shown how difficult it is to remove nuclear waste from the site once it is there.

Although SRS was not designed for long-term storage of nuclear waste, that didn't stop the federal government from sending weapons-grade nuclear materials there. In that case, the plan also was to use the facility only temporarily to house the waste, but it remains there after plans to reuse the nuclear material fell years behind schedule.

Fortunately, the U.S. has an ideal place to store the waste being kept on-site at many power plants nationwide. The nation has invested more than \$10 billion in developing a permanent storage site at Yucca Mountain, Nev.

Planning for the storage site there dates to the mid-80s. The project had been progressing on schedule when, for purely partisan political reasons, President Barack Obama chose in 2009 to abandon the site.

Obama was pressured by Senate Majority Leader Harry Reid of Nevada, who was facing a tough re-election campaign. Reid said dumping waste in his state would hurt the environment; more likely, it would have hurt his political fortune.

Politics aside, the site is ideal for the purpose. It sits in a barren part of the state north of Las Vegas where the government once conducted above-ground testing of nuclear bombs.

Rob Godfrey, spokesman for South Carolina Gov. Nikki Haley, issued a statement last week saying that Haley is "dedicated to keeping South Carolina from becoming a permanent home for this nation's processed nuclear waste."

He added that Haley believes Yucca Mountain should be the final resting place for the spent fuel.

That statement leaves wiggle room for making SRS a "temporary" storage site for the fuel with Yucca Mountain the preferred "final" resting place. But we hope the governor's office isn't playing word games and that she will oppose any plan to bring more nuclear waste to the state.

Opponents in the environmental community need to enlist state lawmakers as well as members of the state's congressional delegation to lobby against this plan.







Our office has located records responsive to your request from October 26, 2012 to the date your request was received, January 23, 2013. Due to the high volume of Freedom of Information Act requests received by the Governor's Office and the significant costs associated with producing the requests, our office will charge a reasonable cost of compiling and copying records as allowed pursuant to Section 30-4-40(b) of the South Carolina Code of Laws.

At this time, we estimate the total number of pages, including attachments, for all incoming correspondence to be 2,340 pages: an estimated 1,465 pages of staff correspondence and an estimated 875 pages of constituent correspondence. Please be advised that a significant volume of responsive records were located that are exempt from disclosure pursuant to Section 30-4-40(a)(7) (correspondence or work product of legal counsel).

For this production, our initial estimate of the total cost is \$424.14: an estimated \$234.00 for copies (2,340 pages at ten cents per page) and an estimated \$190.14 for staff time to compile records (six hours at an hourly wage of \$31.69 per hour).

In response to receiving your deposit for your Freedom of Information of Act request for “all emails and other correspondence sent to the [G]overnor’s [O]ffice regarding the data security breach at the SC Department of Revenue from Oct. 26 through Jan. 25”, we conducted an exhaustive search of responsive records and can provide you the final cost for production. The search and review of responsive records required an extensive amount of time due to the broadness of the request and the very large number of records located.

As previously stated, due to the high volume of Freedom of Information Act requests received by the Governor’s Office and the significant costs associated with producing the requests, our office is charging a reasonable cost for compiling and copying records as allowed pursuant to Section 30-4-30(b) of the South Carolina Code of Laws.

To produce this records request, the total cost will be \$1,279.14: \$381.40 for copies (3,814 pages at ten cents per page) and \$997.74 for staff time to compile records (35 hours at an hourly wage of \$14.26 per hour; and 22 hours, 35 minutes at an hourly wage of \$22.08 per hour), less the payment of the deposit, \$100.00.

With respect to costs for staff time to compile incoming constituent correspondence to the Governor’s Office, our office used the actual hourly rate of the employee who searched and collected those records, \$22.08 per hour. With respect to costs for staff time to compile incoming staff correspondence, our office used the lowest hourly rate of an employee in the Governor’s Office, \$14.26 per hour, putting forth our best effort to furnish records to you at the lowest possible cost in accordance with Section 30-4-30(b). In addition, we removed much of the duplicated correspondence, such as an incoming piece of correspondence to multiple staff




