## The ADA at 25

We were honored to participate in an event organized by the Administration on Community Living last month to celebrate the 25th Anniversary of the Americans with Disabilities Act (ADA). Kevin delivered a keynote speech in which he highlighted how the ADA has been a powerful tool for change for older adults, praised the disability community for its strong and sustained activism and noted that this activism can be a model for aging advocates. ## Celebrating Pride in a Big Way

When the Supreme Court ruled to extend marriage rights to all same sex couples across the nation on June 26, just in time for LGBT Pride, we celebrated. Access to the rights and benefits of marriage is important for everyone, and has an even greater impact on the lives of many older LGBT couples. As we celebrate, we must continue to fight discriminatory practices that linger in the system. That's why we released a fresh version of our 2011 report, [\*\*\*LGBT Older Adults in Long-Term Care Facilities: Stories from the Field\*\*\*](#). The report served as an impetus for San Francisco's Bill of Rights for LGBT Seniors and we hope it

In other LGBT news, we have a hopeful update on our class action against Social Security seeking to stop its practice of going after married LGBT SSI recipients for overpayments paid to them as a result of Social Security's failure to recognize their marriages when it should have.

## **CUFF Act Won't Fight Crime, But It Will Fight Poor People**

The misguided policy that nearly made Rosa Martinez homeless is rearing its ugly head again. Rosa Martinez, a California woman whose SSI benefits were stopped because the Social Security Administration mistook her for a Florida woman with the same name and an outstanding warrant, was Justice in Aging's lead Plaintiff in a case against Social Security. The case successfully challenged the agency's policy of relying solely on the existence of an outstanding warrant to withhold benefits, often for minor infractions like failing to appear in court for a traffic violation, and regardless of whether the person knew about the warrant. The one thing that all of the cases had in common was that the law enforcement agency that issued the warrant had no interest in pursuing the person to secure an arrest. Now two U.S. Representatives have introduced the CUFF Act in Congress, which would reinstitute this unfair policy and throw low-income seniors and people with disabilities who depend on SSI as their sole source of support out on the streets.
