

<MSG>I have been trying since January 25, 2006 to get my mother's Medicaid application process. The first application the agency lost. The second application I sent registered mail on February 22, 2006 it was signed for on February 24, 2006. I finally received a call from the agency on March 9, 2006 from a Ms Torri Dawson. She said she would be sending me a check sheet for additional information and would be sending a level of care letter to the nursing home where my mother was currently staying at getting additional therapy under Medicare. On March 22, 2006 my mother was admitted to Springs Memorial Hospital and is in critical condition. The nursing home admissions office contact the agency and was told that they (Medicaid Agency) would get in touch with me. On March 24, 2006 I called the agency to find out why they had not called me this was around 12:30 pm I was told that a check sheet would be faxed to me, 2 hours later I had to call the agency again and ask Ms Dawson!
where the fax was and she told me she had gotten distracted. I feel that the bill has been dropped. I am now in a situation that if the hospital told me they were doing to discharge my Mother tomorrow I would not know which way to turn. She has has a 3rd stroke and this time I fear she has had sever brain damage. I can not private pay for her to go to a nursing home and I can not care for her at home. I am asking for any help you can provide that would move this application along. I have everything that is need except for four bank statements which I will be ordering on March 27, 2006. Please help.
