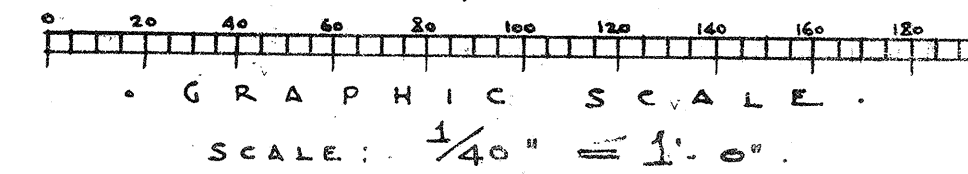
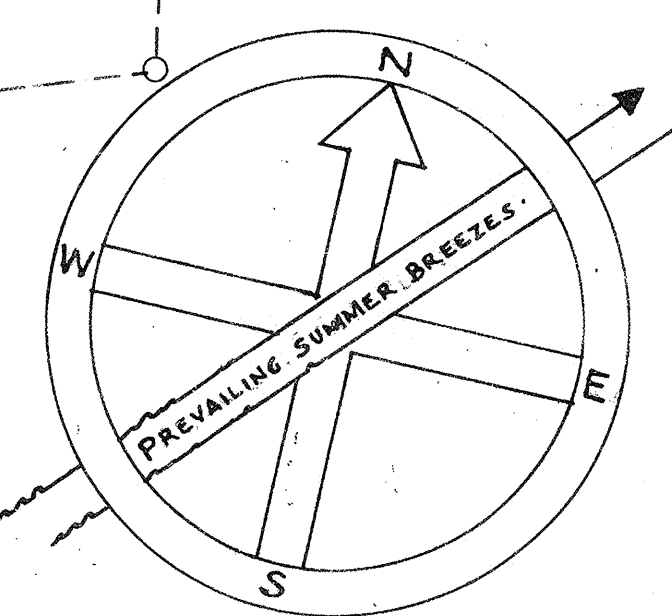

NOTES:

IF THE DIMENSIONED LOCATION OF ANY BUILDINGS BE SUCH THAT PROXIMITY TO UNFORESEEN NATURAL OBSTRUCTIONS OR EXISTING TREES REQUIRE MINOR ADJUSTMENTS TO ACCOMPLISH THE INDICATED RELATIONSHIP, THE CONTRACTOR SHALL CONSULT THE ARCHITECT FOR INSTRUCTIONS IN MAKING THE PROPER ADJUSTMENTS ACCORDING TO THE SPECIFICATIONS.

THE WORK ON THIS SITE UNDER THE GENERAL CONTRACT IS LIMITED TO THE AREA WITHIN THE "ESTABLISHED PROPERTY LINE" WITH THE FOLLOWING EXCEPTIONS:

1. ALL CONCRETE WALKS AND PAVEMENTS SHALL EXTEND BEYOND THE "ESTABLISHED PROPERTY LINE" TO THE LINE OF THE CITY SIDEWALK.
2. ALL SANITARY AND STORM SEWERS, WATER LINES, GAS PIPING SHALL EXTEND BEYOND THE "ESTABLISHED PROPERTY LINE" AND CONNECT WITH CITY AND UTILITY LINES OUTSIDE THE "ESTABLISHED PROPERTY LINE."
