More information below, and I am happy to provide whatever other information may be helpful.

"The National G&T Managers' Association Spring Meeting will be held in Charleston, SC at the Charleston Place Hotel April 2-4. The meeting will have approximately 70 attendees and 40-50 spouses. Of these 70 attendees, the majority will be CEO's of various G&T co-ops from across the country. The remaining attendees will consist

of representatives from National Rural Electric Cooperative Association (NRECA), USDA Rural Utility Service (RUS), National Rural Utilities Cooperative Finance Corporation (CFC), and CoBank, which is a national cooperative bank. I would anticipate CEO representatives of the majority of the states to be in attendance.

The purpose of this meeting is for the leaders of the co-op G&T's to discuss issues and engage each other on issues facing G&T co-ops. The agenda for the two days mostly consists of roundtable discussions amongst the CEO's, with a brief portion of the meeting devoted to updates from the national organizations in attendance.

We need a speaker for the dinner at the Thomas Bennett House on April 3rd. The dinner begins at 7:00 PM and ends at 9:00 PM."
