Thank you for the dial a ride information.

Do you know when the man is coming for the home modifications. Last time we spoke we were told the first part of July, which was a change from the June timeframe we were given.

As right now he can get in out of the home on his own. If the funding is there we don't understand why things are not getting done. We just want straight answers.

One thing I don't understand is why some people are getting the funding for things and get everything they need and Jason Drake seems to not being anything he needs and is placed on a back burner.

If there is that much case load, then someone needs to do something about it. I am trying to keep Jason from going into a facility, which will cost the state way more money. It is more cost effective to be able to keep Jason Drake at home.

We nearing the end of July and have not heard a word from anyone.

Also have you contact a nursing company to find out if they can take his case. Also have you sent a termination of services to Total Home Health. We still do not have the 21 hours required by the state, that have been assigned to Jason for the nursing hours.

We are being told that there is a shortages in LPN/RN. We have requesting that the 21 hours assigned by the states, be used for aid care hours since I am doing his bowel and bladder and he receives the skilled nursing need through my health insurance.

It would actual save the state and be more cost effective give him all 70 hours for attendant care hours, which is what he needs. No company on the list can staff the 21 hours. Jason should not be penalized and lose hours because of staffing issues.
