NASUAD is hosting a Caregiver all-state call on **January 23, 3:30 p.m. ET**, which will feature:

- AARP's State Advocacy & Strategy Integration Government Affairs discussing their plans to advance model legislation to support family caregivers;
- An overview of the [Agingcare](#) website.

Attached is AARP's [2014 State Advocacy Agenda](#), the resolution and plan to advance in 2014; and the [Caregiver Advise, Record and Enable \(CARE\) Act](#),

which will both be reviewed during the call. The CARE Act asks hospitals and rehabilitation facilities to: 1) record the name of the family caregiver in the hospital/facility record; 2) inform the family caregiver when a loved one is moved to another facility or home; and, 3) provide a demonstration of the medical tasks a family caregiver is asked to perform at home.

A Caregiving Resolution was passed in five states in 2013 (Arizona, Illinois, Oklahoma, Tennessee and West Virginia) and an additional 19 AARP State offices are working to pass the Caregiving Resolution in 2014. The following states are working to pass the CARE Act: Hawaii, Illinois, Maryland, New Jersey, New York, Oregon, Puerto Rico, Rhode

Island, and Tennessee.
