That takes the place of the Child Support. It is illegal to keep accruing child support on Jason. Per Tracy stated the Judge back out of what he said, well this was not clarified and explain to Jason. They are causing Jason a lot of stress. Jason is to the point he does not care anymore.

The Judge stated that the \$222.00 was to be the standing payment for child support. The continuous was to be for the \$13,000.00 balance, of which Jason offered her \$50.00 a month to and to add the minor child to insurance: Medical, Dental, Vision, Life insurance and Cancer Policies, of which was declined.

Sign your warrant but when you come Jason up Spartanburg County and the State need to be prepared to take care of him medically and if cannot you will be in violation of his disability rights. As he requires around the clock care.

This is ridiculous!!! Jason is not trying to get out of paying child support, he cannot pay.

Jason wants the court transcripts pulled from the last hearing on this case as that should have recorded every word that was spoken in court. We have extremely ethical issue if the Judge backed out of what was stated and Jason was not notified or this was not clearly stated to Jason. Jason suffers from a traumatic brain injury and spinal cord injury.

Tracy: Jason was served papers today. On that paper work it states that Jason currently owes \$24,343.72 with a court date for April. What I do not understand is his child support was supposed to stop accruing from the date of his last child support hearing and he was also to be credited on the balance at that time back to February when the other party started drawing the \$222.00 social security check for the minor child.

If the other party has a DSS case and is still drawing an FI(Family independence)check then your office needs to communicate to DSS that Jason no longer is accruing child support payments. The \$222.00 is her child support as the Judge stated. It is not Jason's responsibly to make sure the Judge's order is followed and communicated to DSS. Also Jason has made contact with his attorney to let him know what is going on. This issue needs to get corrected quickly.

On the back Child Support we made an offer for Jason to \$50.00 a month on that balance that was listed on the paper work we received when we left the court house and to add the minor child to all of my insurance. Medical, Dental, Vision, Life insurance and Cancer Policies. That offer was "not" accepted by other party. Jason's attorney is supposed to be scheduling a mediation in Spartanburg County and/or a final hearing. It was scheduled in Greenville, however don't have a way to transport him out of the county. Jason would either need to do the mediation in Spartanburg County or have final hearing with a judge. I will scan and email you a copy of the offer we made that Jason's attorney also sent to the other party. The other party declined the offer that is why the mediation was set, but we don't have a way to transport him for mediation in anther county(Greenville).

I have attached is a copy of the power of attorney.
