Scholarship Agreement Between South Carolina State University Foundation And South Carolina State University Board of Visitors

IT IS AGREED, that the South Carolina State University Board of Visitors (BOV) does hereby establish a scholarship fund at South Carolina State University Foundation, Inc. Until otherwise amended, this scholarship fund is to be expended each semester for student scholarships at South Carolina State University according to the criteria outlined.

IT IS FURTHER AGREED

1. That the scholarship fund shall be known as the

SCSU Board of Visitors Student Relief Scholarship Fund

CRITERIA

1. Scholarships of up to \$500 may be awarded per semester within the framework outlined
2. The number of scholarships awarded will be determined by the revenue in the fund
3. Scholarships may be applied for tuition, fees, and/or books;
4. Student recipients must maintain a Grade Point Average of 2.0 or better
5. Priority should be given to students who have demonstrated unmet financial need not provided from other sources
6. Applicants must be in good academic standing in the College of their major and have demonstrated good citizenship in order to apply.

SELECTION

The Director of Financial Aid (or a designee) and a scholarship committee will screen students meeting program criteria for this scholarship. The Director of Financial Aid will also provide a list of eligible applicants with supporting documents to the SC State University Foundation before final awards are announced.

REQUIREMENTS

1. The scholarship shall be funded by annual donations from the members of the SCSU Board of Visitors and listed in the University catalog and other publications where a list of other scholarships is published.
2. Scholarship disbursements will begin once the funds are available. Awards of up to \$500 may be disbursed, assisting as many students as possible during each semester, while maintaining a minimum fund balance of \$100.
3. Each semester the BOV shall be provided with a list of the students awarded the BOV Scholarships and an annual Financial Report (including revenue, expenses/awarded scholarships, and fund balance) after the completion of the Foundation's annual audit.

4. The Director of Financial Aid and/or the Executive Director of SC State University Foundation will have signature authority for this account.
5. Each scholarship of up to \$500 that is awarded shall exist for one (1) semester. If a recipient remains eligible, and funds are available, he or she may reapply for the same amount for a second semester. Upon completion of the second scholarship semester, the student may not re-apply for a period of one year.
6. The recipients must be enrolled at SC State University during the Fall Semester of the academic year for which the scholarship is grant and remain in good academic standing/display good citizenship during the scholarship term.
7. Any false information provided by the student or his or her family will be cause of immediate scholarship cancellation.
8. Scholarship recipients who are expelled or placed on disciplinary probation with the University during the award period will be subject to immediate scholarship termination and are not eligible for future renewals or awards of this scholarship until they are, again, in good standing with the University.

MODIFICATION

This agreement may be revised by the mutual consent of SCSU Foundation and the SCSU Board of Visitors (or their designee). Such consent shall be in writing no later than the first day of July of each year, preceding the academic year in which revision is made to become effective. The BOV may, at any time, convert this expendable fund to an endowment fund by establishing a minimum \$50,000 corpus. At such time, the SC State University Foundation has the right to place this Fund with another money manager for the purposes of investing and distributing such funds annually to SC State University Foundation for purposes as outlined above.


