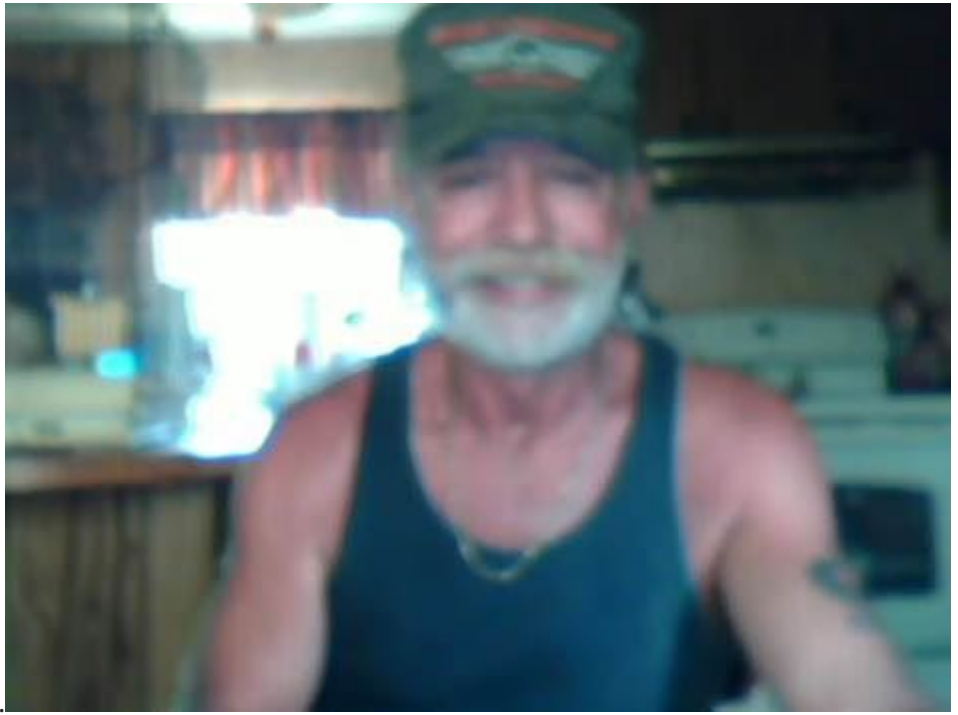

At ft Bragg NC i was going to sleep on duty standing snoring and driving back & fourth to Marion SC with my friend Ethridge S. Hazelden who thought i had Narcolespy because i would go to sleep stnding on duty was written up several time had to pull extra duty and lost wrank. In Basic training at ft Jackson SC in Columbia SC a drill sgt tole me i snore like a tank with a blown engine. At ft Bragg 2/321 fld art 82nd ABN i was asleep one night the CQ sgt Peterson kept wakeing me saying roll over Grice ur snoring so i did not long he was back again wakeing me for snoring after the 5th or 6th time i just sit up tried to knock him out so i get some sleep,i never got a sleep study the sgt Peterson tole Captain Mcpherson he tole me he was going to suspend my pay 6 mos,put me in stockaid and courtmarshal me i got scared came home AWOL over 5 mos mom tole me to go back so i not get shot so went back,we were flown to Instunbull Turkey 1973 made a combat assualt jump,only one i got 600 ft no resurve,in 4-3-79 i went to sleep early am was thrown out a rolling car broke 9 rib's punched left lung,smashed my left knee,got a brain concussion in acoma 2.5 mos in MUSC where i was flown from Marion SC 29571 where i was bourn 9-6-55 & now live on land my dad gave me in 2010,i had to start to work pay child support for 2 kids from first wife that left me in MUSC 4-3-79 was 23 my girl 42 now live in Georgetown SC i messed up my back lumbar on second jump in 1973 at ft Benning Ga my lower back always hurt i not know why till 1990 a etweenman hit my VW left front fender as i turn left he driving like a fool passing me he blew the horn i turn back the jolt mad my lower back hurt worse i went to chiropractor he took a x-ray saw my second vertibrate was one hole vertibrate out alignment,now i have bone cancer,my harley fell 2010 on dirt rd i live on i got a herna picking it up went to dr he took a x-ray saw my second vertibrate out alignment & may west i had 1973 was only time i hit ground hard enough to do that,in 2012 i woke up one night not able to breath i ran to bathroom beating my chest till i caught my breath or i would died locked in my home,i went got a sleep-study done at Carolina hos on hwy 76 between Marion SC & Mullins SC i stop breathing 20 time every hour,i have sleep-apena first car i totaled 1973 on way to jump school at ft Benning Ga after i been their first week was recycled had go through first week again,i work 1-6 jobs from 1981 to 1992 i got on Social Security Disability when i first got on SSD in 1992 it was 508.00 a month now it 875.00 a month i only have 9.00 in my bank account it not last all month,i had left kidney & 13 limph nodes took out 4-7-16 in Carolina hos in Florence SC if Captain Mcpherson not tole me he was going to suspend my pay 6 mos,put me in stockaid & courtmarshal me i would stayed i lived 208 Gregg st Marion SC 29571 when i went in army things i known long i still remember but thing's i just hear are gone in minutes,i have short term memory loss had my left knee total replacement 02 now i can't bend my left knee half way,used to i had walk on my tip-toe because i not able to straighen left leg,can you help get my VA discharge upgreaded so i get VA finical help because of their not giveing me a sleep-study 1973 or 1974 and finding my sleep-apena problem,my home # 843-430-9847 cell 843-430-1927 thank you i hope and Pray i can beat this Bone Cancer can yall help get my VA discharge so it help me & my 3 kid's 2 girl one boy oldest grl 42 bourn 1975 boy bourn 1976 baby girl buy
