Chaney,

I hope all is well. I need confirmation on a few details I just received from the State Election Commission (see email below). We were told that Dorchester County Coroner Chris Nisbet resigned Tuesday. I'm trying to confirm the protocol moving forward. One Dorchester County official indicated that a primary would be held within 11 Tuesdays of Nisbet's resignation, followed by a runoff on the 13<sup>th</sup> Tuesday and a special election on the 18<sup>th</sup> Tuesday. The State Election Commission, however, said that the Governor's office would fill the vacancy until the general election in November. Can you confirm one or the other. Magistrate Judge Katrina Patton is currently serving as interim coroner. Will she continue to serve until an election is held? Thanks for your help!

Christina,

It looks like the Governor would fill this vacancy by appointment until a new coroner is elected in November. Dorchester Coroner was already set to be on the ballot. Candidates will file in March along with all the other partisan candidates seeking office in the general election (filing period is noon, March 16, to noon, March 30). I'll defer to the Governor's office for confirmation on this.

Here's the code section:

SECTION 17-5-50. Vacancy.

(A) Except as provided in subsection (B), in the event of a vacancy in the office of coroner, the Governor shall fill the office by appointing a qualified replacement to serve until the earlier of the following:

- (1) the next general election for the office of coroner; or
- (2) the next general election, in which case an election shall be to fill the unexpired term.

In either circumstance, the person appointed by the Governor shall hold office until his successor shall qualify.

(B) If a county coroner is suspended by the Governor upon the coroner's indictment or for other reasons, the chief magistrate of that county shall act as coroner until the suspended coroner is reinstated or until a coroner is elected and qualifies in the next general election for coroners, whichever occurs first.

(C) Except as provided in subsection (B), the chief deputy or second in command of the coroner's office shall act as coroner until the vacancy is filled by the Governor's appointment. While acting as coroner, the chief deputy or second in command is subject to the duties and liabilities incident to the office of coroner and shall receive the same salary as the former coroner at the time of the vacancy.
