 to my younger brother Bobby house
 trembling. An unidentified white

 from under the carpet and sold it.
 These items were special to her. My
 fathers bed and the refrigerator her
 deceased brother gave to her. This officer
 was so cocky that it didn't matter
 what anybody said he was not doing
 anything. All the suggestions the officer
 had made by getting power of attorney
 over my mother which we have done
 but each officer we call has a different
 story to tell. My mother is 81 years
 old suffering from dementia from the
 cursing and verbal abuse. She has and
 is afraid for her life and ours. She
 has been staying with my younger
 brother Bobby because she is afraid.

and hurt. It is bad enough that the police want returned my telephone call mainly Captain Chad Brooks. I have since contacted the SLED Lt. Elizabeth Corley who put me in touch with him over three weeks ago and neither find that I life matters enough to return my calls. It is a federal crime to destroy mail not belonging to a person. I also have told them my mother said he was burning her mail and Bobby's mail. Min has taken Bobby's registration sticker also from the mail and use or destroy it in the last week. We are on our own. He is continually bringing individuals on the property even allowing them to come when he is not there. Selling items for drugs. He is going to ER trying to get drugs. He was beating my father before his death. He went to the nursing home and told them to stop feeding him Bobby and I had Power of Attorney. We told ~~book~~ ~~document~~ of Attorney. We told nursing home you had no right leaving his food at the door knowing my father

had a broken hip. Alvin has no deciding
making. My father was afraid that
this would happen. He even told his
lawyer very gravely he was going to
have trouble out of him. I promise
my father on his death bed I would
take care of everything. I am going
do that by any means necessary with
or without the help of the Pickens
County Sheriff's Office. They don't
care about crime particularly black
on black crime.
