

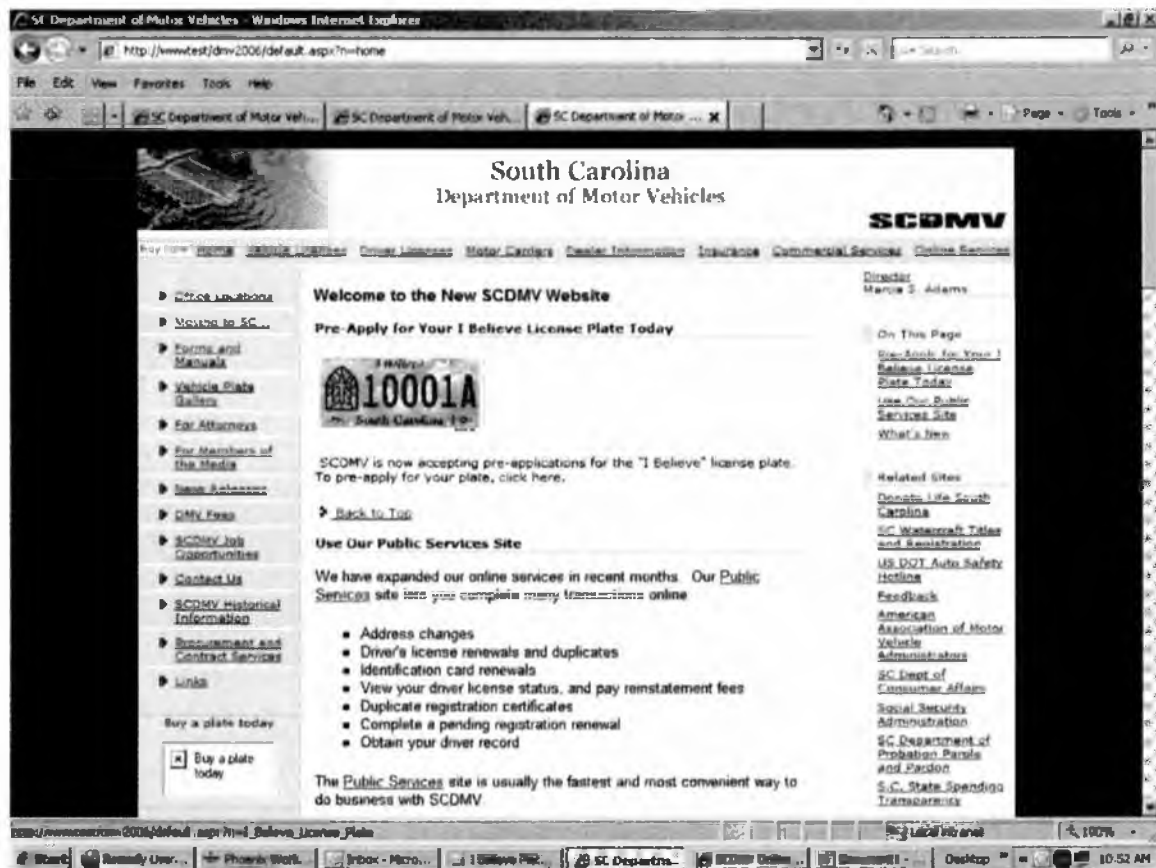

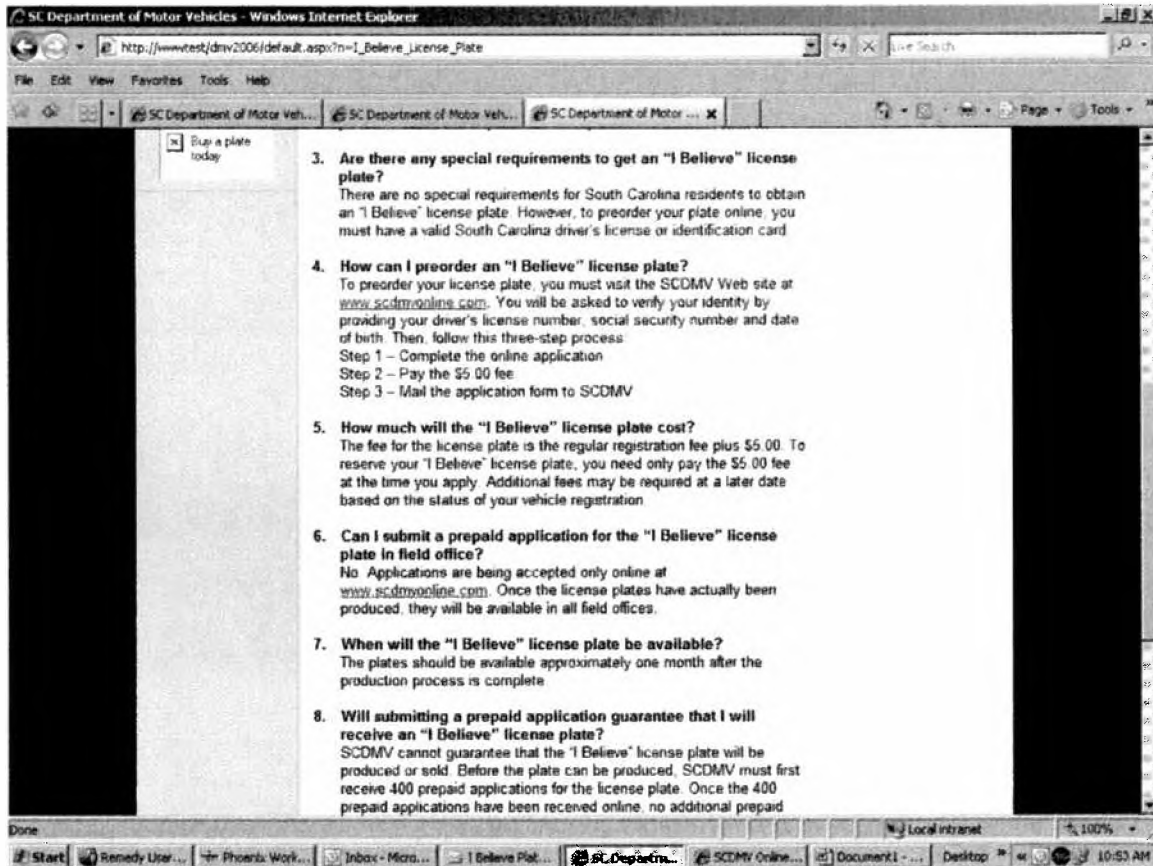

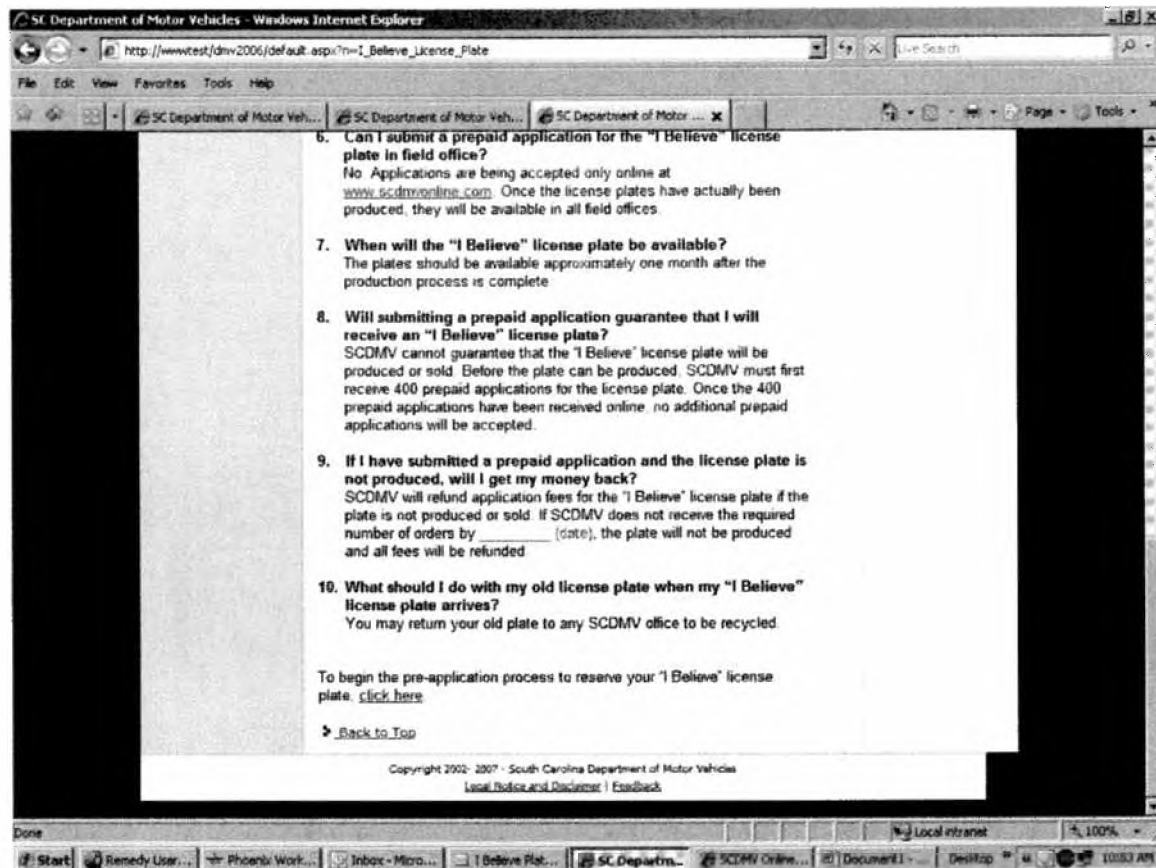
The "Frequently Asked Questions" section lists three questions:

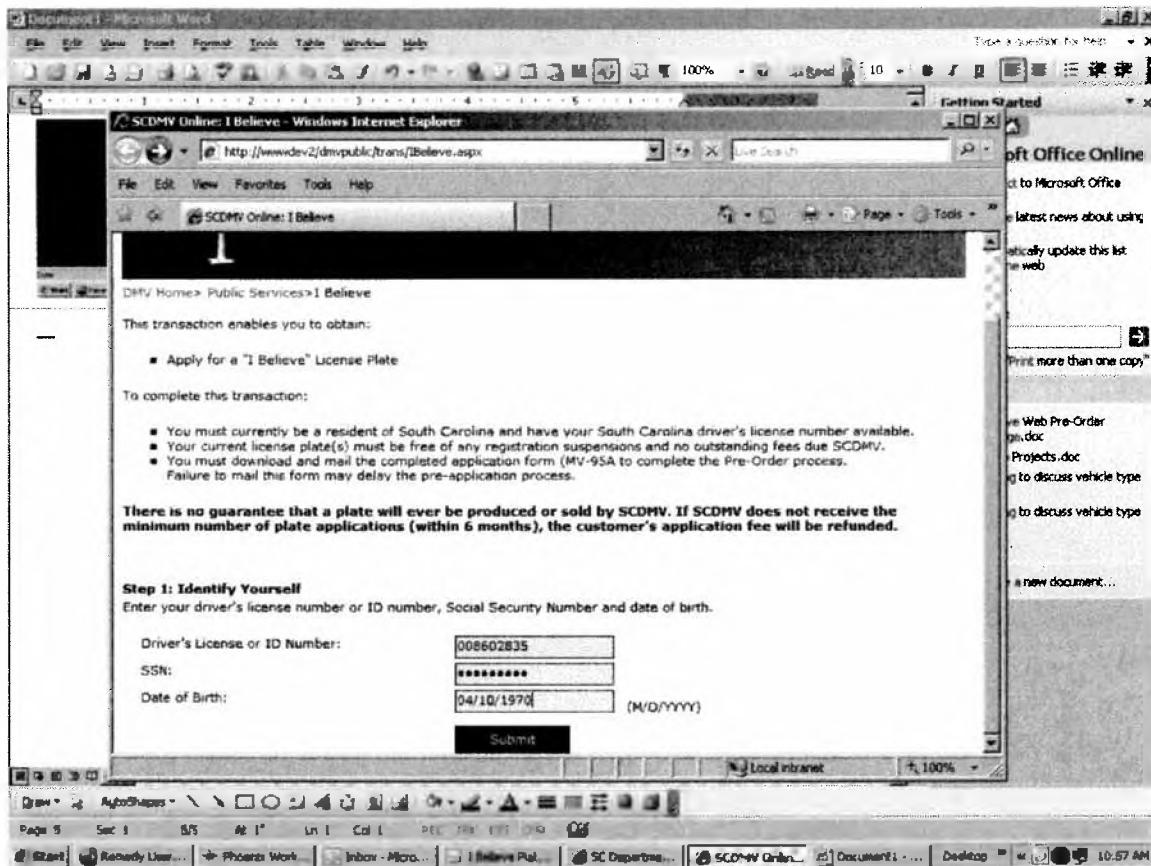
- 1. What is the "I Believe" Plate?**
The "I Believe" license plate was created by South Carolina law and will be available to all South Carolina residents. The license plate design depicts a stained glass window with a cross and the words "I Believe" at the top of the license plate.
- 2. Why can't I order the "I Believe" license plate like any other specialty license plate?**
South Carolina requires 400 prepaid applications before a new plate can be produced. Once SCDMV receives 400 prepaid applications, the plate production process will begin. The license plates will be available to the public as soon as that process is complete.
- 3. Are there any special requirements to get an "I Believe" license plate?**
There are no special requirements for South Carolina residents to obtain

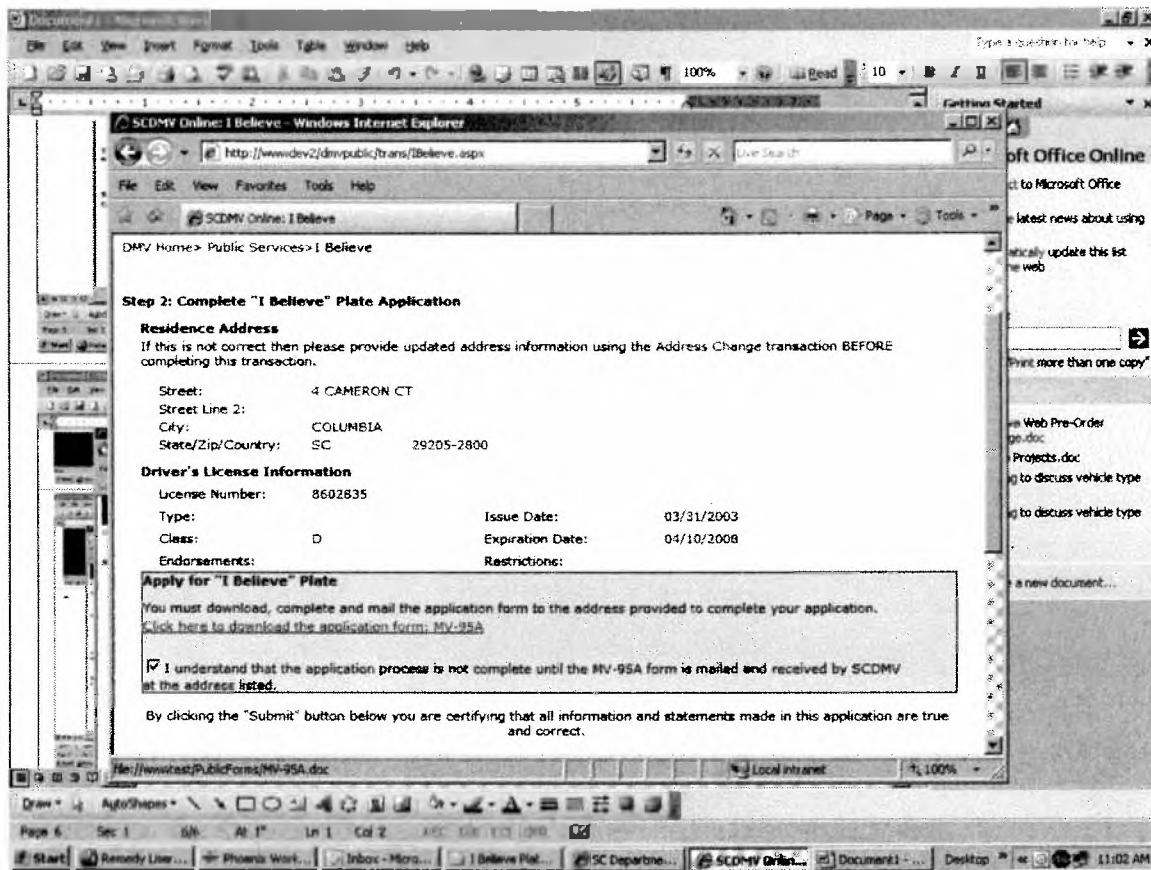

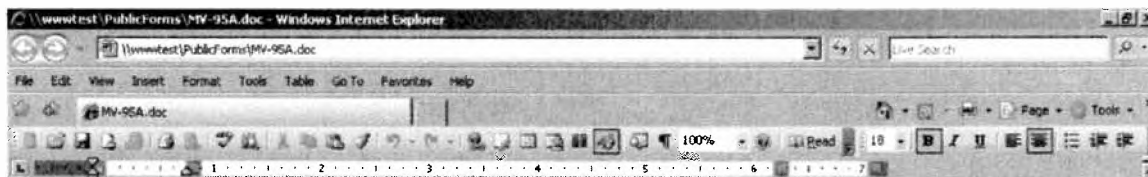

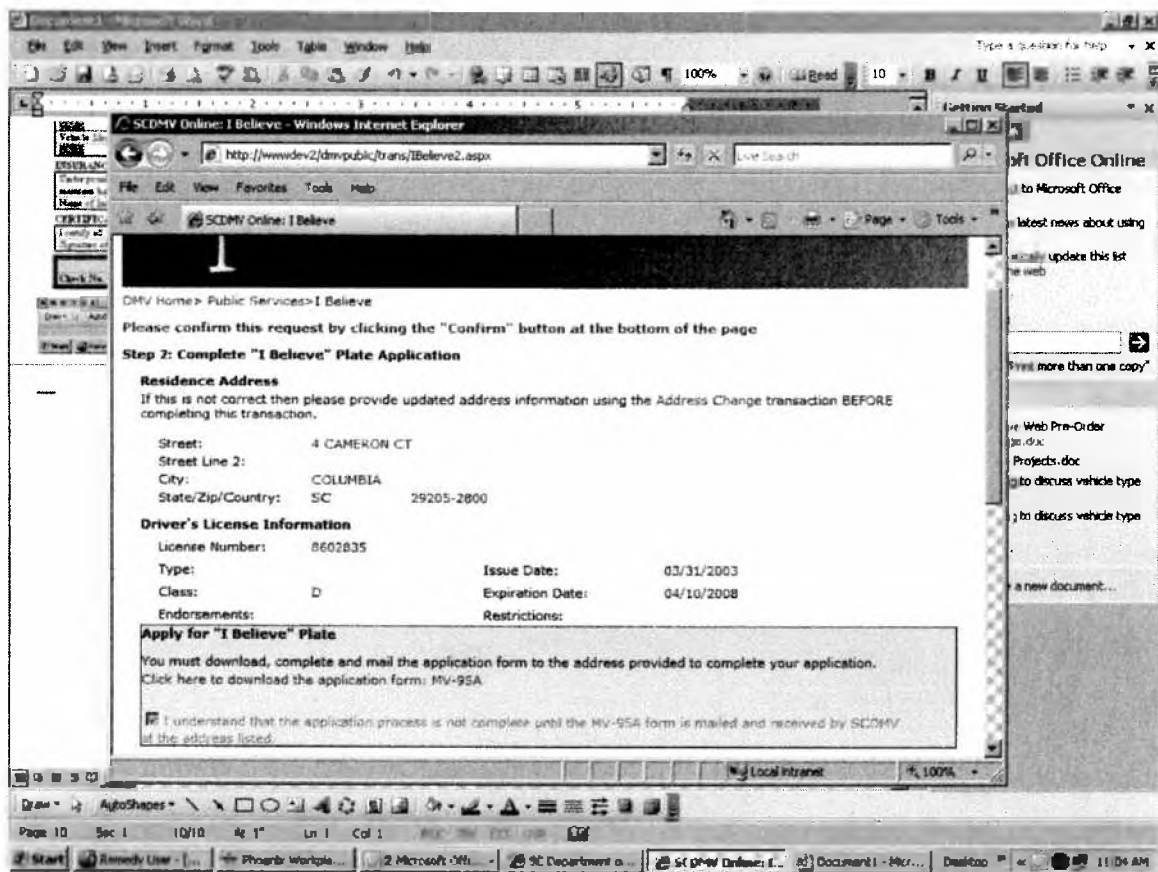
